The following Amended Multiple Ownership Study was conducted to examine the ownership implications that would be created if the Commission grants the contemporaneously proposed Construction Permit Applications for the aforementioned stations of the Commonly Attributable Applicants (the “Applicant”) as proposed in the following Applications:

In addition to the aforementioned stations, the Applicant is also commonly attributable to the following stations within 100 miles of Salt Lake City, UT:

KUUU(FM)	South Jordan, UT
KUDE(FM)	Nephi, UT
KYLZ(FM)	Lyman, WY
KZZQ(FM)	Coalville, UT

The Communities of License for KAUU and KUUU are located in counties which BIA and Arbitron define as being part of an Arbitron Metro.¹ The Communities of License for KUDD, KZZQ, and KUDE are *not* located in such counties but these stations have been defined as being “home” to the Arbitron Market in the last two years.² KMGR and KYLZ have communities of license that are neither located in Arbitron Market counties nor have the stations been defined as being “home” to any Arbitron Market in the last two years.³ Therefore, both the BIA/Arbitron Method and Modified Contour Method shall be employed to examine multiple ownership compliance with Section 73.3555 for the contemporaneously proposed operations of the aforementioned stations for the Applicant.

¹ Pursuant to MB Docket 05-243, Channel 286C was deleted at Manti, UT, and assigned to American Fork, UT, for KAUU(FM)’s use. American Fork is located in Utah County. KUUU(FM)’s community of license, South Jordan, is located in Salt Lake County. Both Utah County and Salt Lake County are part of the BIA/Arbitron Market.

² Pursuant to MB Docket 05-243, Channel 300C was deleted from Roy, UT, and was assigned to Randolph, UT, for KUDD(FM)’s use. Even though Randolph is not in the BIA/Arbitron Market, KUDD has been and is currently serving Roy, UT, located in Weber County, for the past two years and, since Weber County is part of the BIA/Arbitron Market, KUDD(FM) shall continue to be defined as being “home” to the market for at least another two years. KZZQ(FM)’s community of license, Coalville, UT, and KUDE(FM)’s community of license, Nephi, UT, are located in Summit County and Juab County, respectively, outside the BIA/Arbitron Market. However, KZZQ(FM) and KUDE(FM) have been defined by BIA/Arbitron as being “home” to the market in the last two years.

³ Pursuant to MB Docket 05-243, Channel 240C1 was deleted from Delta, UT, and Channel 240C0 was assigned to Randolph, UT, for KMGR(FM)’s use. KMGR currently proposes a one-step upgrade to Channel 240C at Randolph. Neither Delta nor Randolph is located in one of the BIA/Arbitron Market counties and the station has never been defined as being “home” to the market. KYLZ(FM) is licensed to Lyman, WY, which is not located in a BIA/Arbitron Market metro county. KYLZ(FM) had been listed as “home” to the market when it was formerly licensed to Tremonton, UT, up until October 24, 2007, which was more than two years ago.



STUDY #2: Modified Contour Overlap Study – Licensed and Proposed Facilities:

Instantly, KAUU, KUDD, KMGR, and KADQ-FM have Applications for Construction Permits pending before the Commission to implement the Report and Order issued in MB Docket 05-243 where all four stations move to new communities and/or transmitter sites. While these Applications are being processed, all four stations continue operating pursuant to an implied STA under their former licenses (BMLH-20030926APE for KAUU, BMLH-20040624ADL for KUDD, BLH-20080317AAU for KADQ-FM, and BLH-20040729ANB for KMGR).

KUUU, KZZQ, KYLZ and KUDE do not have any pending modifications before the Commission and shall have their licensed facilities examined in each of the subsequent studies.

The following map entitled “Numerators” depicts the principal community contours of the four (4) stations proposed for modification by the Applicant and both their licensed and proposed sites. As can be seen on the map, five (5) mutual overlap markets are created among these stations creating five distinct numerators. Each of the five markets are examined and contrasted in further detail below with their associated denominators for multiple ownership compliance.



In a radio market with 45 or more full-power, commercial and noncommercial radio stations, the Applicant may not be commonly attributable to more than 8 commercial radio stations in total and not more than 5 commercial stations in the same service (AM or FM).

Therefore, the proposal will comply with Section 73.3555 in the subject Contour Overlap Market #5.

CONCLUSION:

The instant Multiple Ownership Study reveals that the instantly proposed assignment of the six (6) stations listed above comply with Section 73.3555 using both the BIA/Arbitron Method and the Modified Contour Overlap Method.
