Board of Trustees. WGBH is a non-stock, non-profit corporation in which no individual or entity holds any ownership interest. There are fourteen Institutional

Trustees representing the institutions listed below in addition to the Lowell Institute. The Lowell Institute serves as an Ex Officio member. At any given time five of the other Institutional Trustees with voting rights, who are elected by the Board of Trustees to serve for three-year terms, serve as Active Institutional Trustees. Representatives of the other eight institutions receive notices of trustee meetings and are welcome to attend, but may not vote. A number of the institutions with which the non-voting Institutional Trustees are associated are themselves the licensees of broadcast stations.

The fourteen institutions are: Boston College, Boston Symphony Orchestra, Boston University, Brandeis University, Harvard University, Massachusetts Institute of Technology, Museum of Fine Arts, Museum of Science, New England Conservatory of Music, Northeastern University, Suffolk University, Tufts University, University of Massachusetts, and Wellesley College.
