Dear Sir:

In an attempt to get some relief, this is the third time I have filed a complaint concerning the interference to my FM Radio Station signal (WBYP-FM) licensed to Belzoni, MS, but serving Belzoni and Yazoo City in Mississippi. We operate on our frequency of 107.1 as a Class C3 channel. The interference is created by a translator in Jackson, MS in Hinds county on our frequency. Their signal is so dominate that it destroys our signal in Hinds and Madison counties and greatly interferes with our signal in Yazoo County our local service area including 4 high schools. Our station is the only local station serving this area. Our engineering study shows there are other channels available in Jackson, MS that could be used by the translator. Furthermore, the translator in question is programmed by a full time FM Station. This should be a violation of the rules.

In this plea for relief, I have included letters from individuals, letters from elected officials who serve a large number of listeners, and information concerning our coverage in Hinds and Madison counties by Arbitron service. We have been serving this audience for over 20 years, and request the FCC remove this interference as soon as possible.




Dear Colon Johnston:


