**ARTICLES OF INCORPORATION
OF
HOPE & HEALING MINISTRIES, INC.**

- ONE:** The name of this corporation shall be: HOPE & HEALING MINISTRIES, INC.
- TWO:** (a) This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes.
- (b) The specific purposes of this corporation are to organize and operate a Christian ministry to offer hope and healing to married couples from the devastation of adultery, and to provide tools for building a Biblical foundation for restoration.
- THREE:** The name and complete business address in this state of this corporation's initial agent for service of process is: Gary Shriver, 3013 East Monte Vista, Denair, California 95316.
- FOUR:** This corporation shall have no members.
- FIVE:** This corporation is organized exclusively for religious purposes within the meaning of Internal Revenue Code Section 501(c)(3) (or corresponding section of any future federal internal revenue law). Notwithstanding any other provision of these *Articles*, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers and the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Internal Revenue Code section 501(c)(3) (or the corresponding provision of any future federal internal revenue law), or (b) by a corporation, contributions to which are deductible under Internal Revenue Code section 170(c)(2) (or the corresponding provision of any future federal internal revenue law).
- SIX:** No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.
- SEVEN:** The property of this corporation is irrevocably dedicated to religious purposes as set forth in Article Two. No part of the net earnings or assets of this corporation shall ever inure to the benefit of any of its officers, directors, trustees, private shareholders or members, or to any individual.
- EIGHT:** Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of this corporation, the remaining corporation assets shall be distributed to an organization (or organizations) that is organized and operated exclusively for religious purposes and that is tax exempt under Internal Revenue Code section 501(c)(3) (or the corresponding provision of any future federal internal revenue law).

EXEMPT ACKNOWLEDGEMENT LETTER
