Dear Ms. Torrado:

This is in reference to the request filed on July 15, 2020. JVC requests a further extension of the STA granted on January 30, 2018, to continue operating ND at night due to equipment problems.¹ In support of the request, JVC stated additional time is needed to complete repairs and test the antenna system.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA IS HEREBY GRANTED, and JVC may continue to operate ND using the daytime tower with a maximum of 5 kW day and 0.25 kW at night, or with nighttime DA parameters at variance and reduced power to maintain monitor

points within licensed tolerances. JVC must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. JVC must submit an e-mail to my attention to certify the date the station resumed licensed operations per BZ-19940715AB with negligible changes (or to note the date an FCC Form 302 application was filed to update all operating parameters).

This authority expires on **February 3, 2021**.
