

**COMPREHENSIVE EXHIBIT**

This short-form application (“Application”) seeks Federal Communications Commission (“FCC” or “Commission”) consent to the *pro forma* transfer of control of New York AM Radio, LLC (“Licensee” or “NY AM Radio”), licensee of station WEPN(AM), New York, NY, Facility ID No. 65636 (“WEPN”).

NY AM Radio is a direct, wholly-owned subsidiary of ABC, Inc., which in turn is a direct, wholly owned subsidiary of ABC Enterprises, Inc., which in turn is a direct wholly owned subsidiary of Disney Enterprises, Inc., which in turn is a direct, wholly-owned subsidiary of The Walt Disney Company (“TWDC”).

TWDC now seeks FCC approval for an internal intra-company transaction (the “Transaction”) by which ABC, Inc. will contribute 100% of its membership interests in the Licensee to its direct, wholly-owned subsidiary ABC Holding Company, Inc., which in turn will contribute 100% of the membership interest in the Licensee to its direct, wholly-owned subsidiary American Broadcasting Companies, Inc., such that American Broadcasting Companies, Inc. will become the sole member of the Licensee. Charts depicting the current and proposed ownership of the Licensee are set forth in Attachment 1 to this Exhibit.

Because TWDC will remain the indirect 100% owner of Licensee both before and after the Transaction, the Transaction will not result in a change in the ultimate ownership or control of Licensee. Accordingly, the Transaction for which FCC approval is sought herein constitutes a *pro forma* transfer of control and use FCC Form 316 is appropriate.

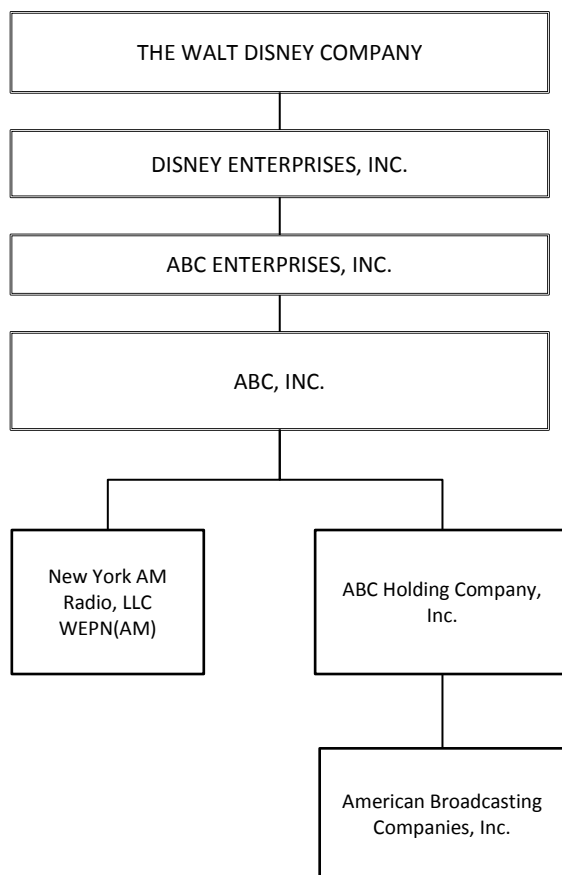
