

The assignee, Minnesota Public Radio (MPR), is a non-profit Minnesota corporation that has been granted tax-exempt status pursuant to §501(c)(3) of the Internal Revenue Code. It has a self-sustaining Board of Trustees whose Trustees are elected by its Board, except that the Board of Trustees of American Public Media Group must approve the election of each MPR Trustee. Each Trustee has one vote. There are two types of Trustees: "Term Trustees" and "Life Trustees". There is no difference between the two types of Trustees, except that Term Trustees may serve for only a limited number of years, while Life Trustees may serve indefinitely. The majority of MPR Trustees are Term Trustees. Approval of the Board of Trustees of American Public Media Group is also required for amendment of the Articles of Incorporation and Bylaws of MPR and for any merger or voluntary dissolution of MPR.

American Public Media Group (APMG) is a nonprofit Minnesota corporation that has been granted tax-exempt status pursuant to §501(c)(3) of the Internal Revenue Code and is a "parent support organization" under the IRS code. APMG provides administrative, financial and human resource services to MPR. It has a self-sustaining Board of Trustees. Each Trustee has one vote. Each APMG Trustee is a member of the MPR Board.
