3. Knight Broadcasting of Baton Rouge, Inc., which wholly owns Knight Broadcasting of Baton Rouge License Corp., licensee of WVLA(TV) (FIN: 70021), Baton Rouge, Louisiana and KZUP-CA (FIN: 24975) Baton Rouge, Louisiana.
4. White Knight Broadcasting of Natchez, Inc., which wholly owns White Knight Broadcasting of Natchez License Corp., licensee of WNTZ-TV (FIN: 16539), Natchez, Mississippi; K61GO (FIN: 16543), Hicks, Louisiana; K67GL (FIN: 16544), Bunkie, Louisiana; K51FO (FIN: 16540), Leesville, Louisiana; and K47DW (FIN: 10405), Alexandria, Louisiana.<sup>1</sup>
