

**ENGINEERING STATEMENT COVERING
BROADCAST MULTIPLE OWNERSHIP STUDY
CCR-BUTTE IV, LLC
BUTTE, MONTANA**

JANUARY 2014

This engineering statement and supporting tabulations and figures have been prepared on behalf of **CCR-Butte IV, LLC (“CCR”)**. The purpose of this statement is to demonstrate continued **CCR** compliance with *Section 73.3555* of the Commission’s Rules with respect to multiple ownership of AM and FM broadcast facilities. This study is filed for the purpose of reflecting a change in ownership structure for the commonly owned stations in the market. No facility changes are associated with this filing.

CCR proposes continued common ownership in the following three stations in the Butte, Montana market:

KXTL(AM)	Butte, MT.	1370 kHz	5 kW DA-N	Fac. ID #63871
KMBR(FM)	Butte, MT.	95.5 MHz	50.0 kW	Fac. ID #63875
KAAR(FM)	Butte, MT.	92.5 MHz	4.5 kW	Fac. ID #63877

The stations are not licensed to Arbitron Metro counties and thus the contour method was used to determine the number of stations in the market. These three stations are considered as one market since the principal community contours for all three stations have an area of common overlap. It is noted that CCR owned stations KBLL-FM and KZMT(FM), both allocated to Helena, Montana, overlap a portion of the KMBR and KAAR contours. These stations are not counted in this market and are addressed fully in the market study prepared for CCR-Helena IV, LLC. The market coverage analysis was undertaken by BIA and is attached.

A review of the BIA study shows that 22 other stations duplicate some portion of the market. Based on the above analysis, it is believed that the proposed common ownership of stations complies with *Section 73.3555(a)(1)(iii)* of the Commission’s Rules. There are 17 other FM and 5 other AM stations considered in this study which are listed on pages 6 and 7 of the BIA study and whose principal community contours overlap some portion of the KMBR (FM) 70 dBu contour. Since CCR can own up to four stations in the

same service, overlap with KMBR(FM) and KAAR(FM) is permitted as is demonstrated fully in the CCR-Helena IV, LLC market analysis.
