### **Advancement of Educational Program**

The Athabascan Fiddlers Association, Inc., proposed assignee of the construction permit for noncommercial educational radio station Station KRFF(FM), Fairbanks, Alaska, respectfully submits the following explanation of its educational objective and the manner in which the station will be used for the advancement of an educational program that will further that objective, in accordance with Section 73.503 of the FCC's Rules, 47 C.F.R. § 73.503.

The Athabascan Fiddlers Association is an Alaska-chartered, Federally-recognized 501(c)(3) non-profit organization headquartered in Fairbanks, Alaska, and operating throughout the state's Interior region. Since its founding in 2001, The Athabascan Fiddlers Association's mission has been "Sharing, perpetuating, and preserving Athabascan culture, traditions, and values, through presentation, documentation, and education." A significant program of the Athabascan Fiddlers Association has been planning and carrying out the annual Athabascan Fiddlers Festival in the fall – this celebration of Athabascan culture and music brings together people from all across Alaska's vast Interior region to share, perpetuate and preserve Athabascan culture and traditions.

The Athabascan Fiddlers Association's planned operation of KRFF(FM) will serve the educational needs of the Fairbanks community, as well as advancing the Association's educational objectives and missions. The Athabascan Fiddlers Association shall furnish a non-profit and noncommercial radio broadcast service over KRFF(FM), and plans to broadcast music, cultural events, cultural education offerings, news and community information throughout the Interior region of Alaska. In terms of programs and services, the station will offer cultural programming, local, state and national news, and community information. The programming will better allow The Athabascan Fiddlers Association to meet its cultural mission through use of the public airwaves. In addition to providing programming with a greater focus on cultural issues, the station will establish an essential communication channel with rural Alaska; in so doing, there will be year-round sharing of Athabascan culture and traditions. It is the intention of The Athabascan Fiddlers Association to encourage local participation in programming in order to include much greater involvement from Athabascan elders. The Athabascan Fiddlers Association will work to ensure that the noncommercial educational programs broadcast over KRFF(FM) will be responsive to issues of concern to listeners in its local community.
