Dear Counsel:

This is in reference to the request filed March 14, 2012, on behalf of Entercom Wichita License, LLC (Entercom). Entercom requests extension of the special temporary authority (STA) granted on December 20, 2011, to operate Station KFBZ with reduced power.¹

In support of the request, Entercom states that, following its initial repair work on the transmission line, it has discovered additional moisture leaks and determined that further work is necessary.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted.

¹ KFBZ is licensed for operation on Channel 287C0 (103.7 MHz) with effective radiated power (ERP) of 100 kilowatts (Max-BT, H&V) and antenna height above average terrain (HAAT) of 307 meters.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KFBZ may continue to operate with reduced power, using one-half of the licensed antenna as an emergency antenna. Entercom must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **November 16, 2012**.
