A Petition for Reconsideration and/or Clarification was filed with the FCC on June 13, 2001, by Sutton Radiocasting Corporation, seeking reconsideration of the FCC's Memorandum Opinion and Order (FCC 01-129), released May 25, 2001, which granted Liberty's Application for Construction Permit (File No. BPH-19870831MI), or in the alternative, clarification that the FCC "did not accept for filing or grant Liberty's requested one step upgrade from Channel 243A to Channel 243C3".

A Petition for Reconsideration was filed with the FCC on September 5, 2001, by Sorenson Southeast Radio, LLC, seeking reconsideration in part of the FCC's Memorandum Opinion and Order (01-129), released May 25, 2001, which granted Liberty's Application for Construction Permit (File No. BPH-19870831MI). An Informal Objection was filed with the FCC on May 10, 2002, by Sutton Radiocasting Corporation, a successor in interest to Sorenson Southeast Radio, LLC, opposing the grant of Liberty's Application for License (File No. BLH-20020220AAL) and requesting that the same be held in abeyance pending resolution of the pending Petition for Reconsideration.

A Petition for Writ of Certiorari was filed with the U.S. Supreme Court by Biltmore Forest Broadcasting FM, Inc. on July 8, 2003, and assigned Docket No. 03-48, which sought review of the judgement of the U.S. Court of Appeals for the District of Columbia Circuit in Case No. 01-1392. Certiorari was denied by Order filed November 3, 2003. The time for filing petitions for rehearing has expired, as of the date of this Agreement.
