

Audacy License, LLC
WWWL(AM) New Orleans, LA.

The above referenced construction permit contains a condition (#5) which requires either dismantlement of the now unused second tower of the WWWL antenna or as an alternative, a proof of performance to demonstrate that the permitted antenna is essentially omnidirectional.

Audacy respectfully requests removal or waiver of this condition as we feel it is unnecessary.

The non-directional antenna authorized for nighttime operation is the same antenna that has been used for non-directional daytime operation for decades. There is no reason to believe its radiation characteristics at night will be in any way different than during daytime hours. Furthermore, non-directional measurements of this antenna are part of the directional antenna proof of performance which was conducted when the antenna was first constructed, and are therefore already on file with the Commission.
