**§307(b) Comparison - Camden / Springdale, South Carolina**

This application seeks to change the community of license of WEAF, 1130kHz, from Camden, South Carolina to Springdale, South Carolina using the recently adopted city of license change procedures as outlined in MB Docket #05-210, released November 29, 2006. This is a review of the proposed change and demonstrates compliance with the Commission's new rules and procedures for a change of community of license.

The proposed facility at Springdale, South Carolina is mutually exclusive with the licensed WEAF facility at Camden, South Carolina. WEAF is not the only station presently licensed to Camden, South Carolina. AM Station WCAM, 1590 kHz, and FM station WPUB-FM, Channel 274A, are both licensed to the community. As a result of the proposed change, the community of Springdale will receive its first locally licensed/ operational station without depriving Camden of its only local service.

Exhibit #1B1 is a coverage map for WEAF at Springdale, South Carolina showing the proposed facility will provide a 5.0 mV/m contour over all of the proposed new community of license. The proposed site is an existing tower; therefore, it is suitable for the relocation of WEAF (ASRN 1212033).

Therefore, Glory Communications, Inc., proposes the following:

The existing WEAFF at Camden, South Carolina provides a 2.0 mV/m contour to 33,026 persons in 801 square kilometers and a 0.5 mV/m contour to 85,509 persons in 2,874 square kilometers. The proposed WEAFF at Springdale will provide a 2.0 mV/m contour to 315,235 persons in 808 square kilometers and a 0.5 mV/m contour to 489,472 persons in 2,493 square kilometers. WEAFF is proposing only 0.009 kilowatt of nighttime power; the nighttime interference free signal is 5.36 mV/m which encompasses 7,482 persons in 26.0 square kilometers.

Exhibit #6A is a tabulation of the stations providing protected service to the proposed community of license of Springdale. Exhibit #6BA provides a visual depiction of the stations providing protected service to Springdale

Springdale is a community deserving of a locally license station. By changing its community of license and relocating, the proposed WEAFF would provide that service to Springdale.

Springdale was incorporated in 1955 and has a population of 2,877.<sup>1</sup> It has a Town Council with a Mayor and six Council Members who oversee the community. Springdale has a Town Hall with its own Municipal Court and Clerk of the Court. The community has its own Police Department and a Public Works Department that provides curbside trash collection and maintenance for the city parks and streets. The community of Springdale also has many businesses and churches that are identified with Springdale by the use of “Springdale” in their name.

Springdale is located in the Columbia, South Carolina Urbanized Area and an analysis to show independence from Columbia is included elsewhere in this submission.


