Emmis also owns all of the issued and outstanding voting stock of KOIN-TV, Inc., the licensee of KOIN(TV), Portland, Oregon, Low Power Television Station K11SE, Bend, Oregon, and Television Translator Stations K31CR, Prineville, Oregon, K34DC, Astoria, Oregon, and K38CZ, Lincoln City, Oregon, K52AK, Prineville, Oregon, K64BK, The Dalles, Oregon,

Additionally, Emmis owns all of the issued and outstanding voting stock of Wichita License Subsidiary Corporation, licensee of KSNW(TV), Wichita, Kansas, KSNC(TV), Great Bend, Kansas, KSNG(TV), Garden City, Kansas, KSNK(TV), McCook, Nebraska, and Television Translator Station K06LZ, Salina, Kansas, Facility Id. Finally, Emmis owns all of the issued and outstanding voting stock of Topeka License Subsidiary Corporation, the licensee of KSNT(TV), Topeka, Kansas, Facility Id. No. 67335.

## **II. Proposed Assignment**

It is the intention of Emmis to consolidate the licenses of the above-referenced television stations, associated low power and television translator stations, and associated broadcast auxiliary stations into Emmis Television License Corporation of Honolulu, which is an existing wholly-owned subsidiary of Emmis License Corporation.

Similarly, it is the intention of Emmis to consolidate the licenses of the above-referenced radio stations and associated broadcast auxiliary stations into Emmis FM License Corporation of St. Louis, which is an existing wholly-owned subsidiary of Emmis License Corporation.

Under this new corporate structure, Emmis Communications Corporation would continue to hold 100% of the issued and outstanding corporate stock of Emmis License Corporation, and would thereby retain ultimate control over the licenses currently held by the above-referenced subsidiaries. Accordingly, (i) there will be no substantive change in control whatsoever, (ii) the proposed assignment is *pro forma* in nature, and (iii) processing on FCC Form 316 is appropriate.

The assignment proposed herein will be accomplished through merger of the assignor into the assignee. There exists no written agreement relating to the merger.
