


## Exhibit 10

### **Changes in Interests as a Result of Stock Transfer (Response to Form 316, Section III, Item 5a.)**


As indicated elsewhere in this application, the requested pro forma transfer of control of licensee Soda Mountain Broadcasting, Inc. (“SMB”), nunc pro tunc, results from corporate restructuring undertaken in December 2000. That restructuring involved the formation of an intermediate corporation in the chain of ownership between SMB and its then sole shareholder, Chambers Communications Corp. (“CCC”). In addition, CCC changed its name to Pleasant Hill Corp. (“PHC”) and the new intermediate corporation, which is wholly owned by PHC and now holds 100% of the stock of SMB, was given the name Chambers Communications Corp. (which is referred to herein as “New CCC” to avoid confusion between it and the former CCC, now named PHC).

Thus, the ownership structure before and after the transfer of control of SMB is as follows:

Both before and after the transfer of control of SMB from PHC to New CCC, Carolyn S. Chambers votes the 84% voting stock<sup>1</sup> held by the Carolyn S. Chambers Trust (the “Trust”) in PHC. The Trust is a domestic trust and Carolyn S. Chambers, the trustee and beneficiary of the Trust, is a U.S. Citizen. Ms. Chambers’ address is 86220 Dery Road, Pleasant Hill, Oregon.

Carolyn S. Chambers is also the sole Director, Chairman, Chief Executive Officer and Treasurer of each above-identified corporation in the chain of ownership before and after the transfer of control.

<sup>1</sup> The remaining voting stock in PHC (an aggregate of 16%), both before and after the transfer of control, is held by several shareholders, each of whom holds less than 5% and therefore is non-attributable and non-reportable.

Silva Sullivan, daughter of Carolyn S. Chambers, is the current President and Chief Operating Officer (“COO”) of PHC. Ms. Sullivan is a U.S. citizen and her address is 86054 Dery Road, Pleasant Hill, Oregon. Ms. Silva assumed the position of President and COO of PHC in December 2000, upon its name change from CCC and the formation of New CCC.

Scott Chambers, son of Carolyn Chambers, is the current President and COO of SMB and New CCC. Mr. Chambers is a U.S. citizen and his address is 86195 Dery Road, Pleasant Hill, Oregon. Mr. Chambers was the President and COO of CCC (prior to the name change to PHC and the formation of New CCC).

John C. Ohm, a U.S. citizen, was the Secretary of PHC and SMB prior to the formation of New CCC and he remains the Secretary of PHC and KEZI, Inc. He also holds the position of Secretary of New CCC. Mr. Ohm’s address is 2262 Ridgeway Drive, Eugene, Oregon.

James L. Plummer, a U.S. citizen, was the Vice President/Finance of PHC prior to the formation of New CCC and he continues to hold the position of Vice President/Finance of PHC. Mr. Plummer’s address is 2120 Jackson Street, Eugene, Oregon.
