PETITION FOR RECONSIDERATION PATONER, HEALD & HILDRETH

The University of Central Missouri ("UCM"),<sup>1</sup> under Section 1.106(a) of the rules, hereby seeks reconsideration of the action taken by the Audio Division dismissing UCM's captioned application for minor changes to Station KTBG, Warrensburg, Missouri. The KTBG application was dismissed through a staff letter released September 10, 2007 (by processing engineer Khoa Tran). In support of reconsideration the following is shown:

This petition is timely filed within 30 days after public notice of the dismissal of UCM's application, which public notice was released on September 13, 2007 (Report No. 46570).

UCM seeks reconsideration and reinstatement *nunc pro tunc* or its application based on the curative amendment attached hereto.<sup>2</sup> The amendment eliminates the

overlaps pointed out in the FCC's September 10, 2007 letter, thereby mooted the technical flaws which caused the application to be dismissed.


On the basis of the changed circumstances presented in the amendments, the Commission should reconsider its dismissal of UCM's applications and reinstate it *nunc pro tunc*. *James River Broadcasting Corp. v FCC*; 399 F 2d 581 (DC Cir. 1968) (application may be accepted for filing where an amendment cures a defect which existed as of the cut-off date). Once reinstated, the application should be granted.

WHEREFORE, It is respectfully requested that the Commission accept the minor amendment submitted by UCM, reinstate its KTBG minor change application *nunc pro tunc*, and grant the application.






## INTERFERENCE ANALYSIS—EXHIBIT 16

An interference analysis for the proposed facilities was conducted according to FCC Rule 73.509. Three contour maps are shown to indicate a wide view, and close-up views where it is demonstrated that contour overlap to the protected contours of other authorized facilities does not occur.


The red contours indicate the co-channel protected contours of other authorized facilities and the interfering contour of the proposed facilities. The green contours indicate the adjacent channel protected contours of other authorized facilities and the interfering contour of the proposed facilities. The black contours indicate the 2<sup>nd</sup> & 3<sup>rd</sup> adjacent channel protected contours of other authorized facilities and the interfering contour of the proposed facilities. In many cases the black contours of authorized facilities are not included because they are so far away and only serve to clutter the map.

As can be seen from the attached maps, no contour overlap with any co-channel, adjacent channel, and 2<sup>nd</sup>/3<sup>rd</sup> adjacent channels exists.




