We have reviewed the Construction Permit (FCC File No. BPFT-20130710ACT) for FM Translator W277AM - Portland, ME (Facility ID No. 149580), and agree to waive Condition #3 on the Construction Permit requiring field strength measurements (a partial proof of performance) on WLOB(AM) - Portland, ME (Facility ID No. 9202) to establish the WLOB(AM) 1310 kHz array will not be adversely affected by the constructing of W277AM. We see this as unnecessary and may be removed.

WLOB(AM) and Atlantic Coast Radio, LLC, support the deletion of Condition #3 from the W277AM Construction Permit, as WLOB(AM) is presently operating under BSTA-20130927AHW for parameters of variance. Atlantic Coast Radio is also presently in the process of returning WLOB(AM) to licensed operation. Resumed operation is slated for late June 2014 and the existing STA will be extended as necessary to complete the project.
