**RESPONSE TO REQUEST FOR INFORMATION**

Comes now, Roy E. Henderson, (“Henderson”), Licensee of Radio Station KTWL (FM), Todd Mission, Texas (FAC# 21204) (“KTWL” or “Station”), by his counsel, hereby respectfully submits its Response to the September 16, 2019, reference 1800B3-KV (the “FCC Letter”) in connection with complaints and a Petition for Reconsideration filed by Henderson with regards to the above captioned applications and translator. With respect thereto, the following is submitted<sup>1</sup>.

As is previously on record with the Commission, Henderson has complained regarding the operations of FM Translator Station K287BQ (FX), Houston, Texas by Centro Cristiano de Vida Eterna (“Centro”). On numerous occasions Henderson has discussed the interference issue with Centro, but to no avail. Because of this continuous interference problem, Henderson has submitted numerous complaints and is now doing so again.

As part of this submission, please find attached hereto Declarations of seven (7) regular listeners of KTWL (FM) whom have no legal, familial, employment or business financial interest with the Station<sup>2</sup>.

Also attached hereto are the Technical Comments (the “Study”) prepared by Clifton G. Moor of Bromo Communications, Inc<sup>3</sup>. This Study indicates that that the Centro facility and proposed facilities cause objectional interference to these listeners, as the undesired to desired signal exceed -20 dB for all of the listeners<sup>4</sup>. The Study depicts the KTWL 45 dBu contour, the area of predicted interference and the location of the complainants<sup>5</sup>. Additionally, the study shows that the population within the KTWL 60 dBu contour is 159,430 persons<sup>6</sup>. At that population count, the minimum complainants required is six (6). Lastly, Engineer Moor has confirmed that the KTWL transmitter plant is operating with its licensed paraments<sup>7</sup>.

Henderson has met the new Commission requirements<sup>8</sup> relating to the translator interference complaint process. Having met the new standard, Henderson respectfully requests the dismissal of Centro’s applications BPFT-20181101ABB and BPFT-20190221ABD pursuant to *47 C.F.R. Section 74.1204(f)*. Futher Henderson, requests that Centro be required to immediately address the current licensed operations under BLFT-20190219ACC and its





**KTWL "Texas Mix"** becomes completely overridden by K287BQ at the Grand Parkway (TX-99)/Interstate 10 interchange near the town of Cypress (77410).

From the town of Cypress (77410) southeasterly to the town of Houston (77001), K287BQ is the only signal that can be heard on 105.3 FM.

Until recently, I have been able to clearly hear **KTWL "Texas Mix"** at my office on the north side of the city of Houston (77001).





Population within the KTWL licensed 60 dBu contour is 159,430 persons. Therefore a minimum of 6 listener complaints are required.

KTWL continuously ascertains that its transmitter plant is operating within its licensed parameters.


Attached is the map "KTWL Listener Complaint Locations". These are the locations that listener complaints pass the Undesired-Desired ratio. At each of these locations the K287BFQ translator signal is greater than the -20 dB ratio required for no interference. That tabulation is also attached.
