

Changes in Interest

The proposed *pro forma* assignment of license is being filed to assign the licenses of KOMO-FM, Oakville, WA (Facility ID 51167), KOMO-FM1, Tukwila, WA (Facility ID 190282), and K249DX, Redmond, WA (Facility ID 149955) (the “Stations”) from Chesapeake Television Licensee, LLC (“Chesapeake Television”), an indirect wholly owned subsidiary of Sinclair Broadcast Group, Inc. (“SBG”) to Sinclair Radio of Seattle Licensee, LLC (“Sinclair Radio”), another indirect wholly owned subsidiary of SBG.

SBG is the sole stockholder of Sinclair Television Group, Inc. (“STG”), which is the sole member of Sinclair Communications, LLC, which is the sole member of Chesapeake Television (the current licensee of the Stations). STG is also the sole stockholder of Sinclair Television of Seattle, Inc., which is the sole stockholder of Sinclair Television Media, Inc., which is the sole member of Sinclair Radio (proposed assignee). As such, the proposed transaction does not involve changes to the ultimate beneficial ownership of the Stations.

Percentage of votes of individual shareholders is as of May 8, 2020 (as reflected in SBG’s most recent 13D filing with the SEC, dated May 11, 2020). Where an individual who is attributable by virtue of their positional interest holds less than a 5% voting interest or less than a 5% total assets interest in SBG, we have reported those interests as 0%. In addition, SBG is a publicly traded company. As a result, the number of shares held by any shareholder is subject to change at any time. Currently, SBG is not aware of any individual shareholder that holds an attributable interest in SBG except as reported herein. To the extent that SBG learns that any individual shareholder obtains an attributable interest during the pendency of this application, it will submit an amendment to reflect such change.
