Multiple Ownership

The attached BIA FCC Geographic Market Definition for Columbus, GA, shows 21 stations in that geographic market. Pursuant to Section 73.3555(a)(1)(iii) of the Commission's Rules, an entity may own six commercial stations in such a market, no more than four of which may be AM or FM.

The attached BIA market definition shows that the applicant and affiliated entities currently own four FM and two AM stations in the Columbus market. By this application, filed pursuant to FCC Report and Order MB Docket No. 03-223, released December 16, 2005, the applicant proposes to relocate one of its Columbus market FM stations, WIOL(FM), Greenville, GA, to Waverly Hall, Georgia, which is also in the Columbus market. At the conclusion of the relocation, the applicant and affiliated entities will continue to own four FM and two AM stations in the Columbus market and will continue to comply with Section 73.3555(a)(1)(iii) of the Rules.
