Dear Mr. Davis:

This is in reference to the request filed on April 21, 2020. CLI requests an extension of the STA granted on October 29, 2019, to continue operating with nighttime parameters at variance to allow time to file an FCC Form 302 application after completing all modifications/testing.¹ In support of the request, CLI stated that additional time will be required to file the application with a new method of moment proof.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and CLI may continue to operate at night with parameters at variance, while maintaining monitor points within licensed limits as the array is being adjusted, with no change to the licensed daytime 1 kW

operation. CLI must reduce nighttime power or cease operation if complaints of interference are received, and use must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. CLI must submit an e-mail to my attention to note the date the application was filed.

This authority expires on **November 12, 2020.**
