**Re: Request for Special Temporary Authority
Station KAYU-TV, Spokane, Washington**

Dear Sir or Madam:

Mountain Licenses, L.P. ("MLLP") is the licensee of Station KAYU-TV, Spokane, Washington (Facility ID No. 58684). KAYU-TV is a Fox Network affiliate that currently operates on pre-transition DTV Channel 30 pursuant to a grant of phased-transition relief. *See* FCC File No. BDSTA-20080530ABH. MLLP has been issued a construction permit for KAYU-TV's post-transition DTV Channel 28 facility (FCC File No. BPCDT-20080402AAX), and anticipates that construction of that post-transition facility will be completed on or about September 15, 2009. *See* FCC File No. BDTUCT-20090720ABR. MLLP, by its attorneys, hereby respectfully requests Special Temporary Authority ("STA") to continue to operate KAYU-TV on its pre-transition DTV Channel 30 for a period of 30 days after it commences program tests on DTV Channel 28. Grant of this request is urgently needed to avoid a temporary loss of KAYU-TV's programming service to potentially hundreds of thousands of viewers when KAYU-TV completes its transition to DTV Channel 28.

KAYU-TV's over-the-air programming service is retransmitted by 14 TV translators located in Washington, Idaho and Montana. In addition, a number of local cable systems located in Washington and Idaho are fed via KAYU-TV's over-the-air signal. Unless KAYU-TV is granted temporary authority to continue operating on DTV Channel 30 after it completes its digital transition, these TV translators and cable systems will be unable to receive KAYU-TV's over-the-air signal until their digital input channels have been changed from DTV Channel 30 to DTV Channel 28. As explained more fully below, this temporary service loss could potentially affect hundreds of thousands of viewers, and can be avoided only if KAYU-TV is permitted to continue operating on DTV Channel 30 for a short transitional period while the necessary digital input channel changes are implemented.



The call signs, communities of license and Grade A contour service populations (2000 Census) for each of the 14 TV translators that retransmit KAYU-TV are set forth in the table below. The TV translators marked by an asterisk (*) are licensed to MLLP.

The process of changing the digital input channel for these TV translators will be time consuming. In each case, engineering personnel must visit the station's transmitter site to install tower-mounted preamplifiers and band pass filters. Since many of these transmitter sites are located on remote mountaintops, MLLP reasonably anticipates that it will take approximately three weeks to complete the digital input channel changes for these 14 TV translators.

In addition, MLLP estimates that approximately 55,599 households are served by cable systems that are fed by KAYU-TV's over-the-air signal. Each of these cable systems also will be unable to receive KAYU-TV's DTV Channel 28 signal until the necessary digital input channel change has been implemented. Although MLLP is reasonably confident that larger cable systems have the resources to implement this digital input channel change relatively quickly, smaller local cable systems often have limited technical personnel available to perform this task. For these smaller systems, MLLP reasonably estimates that it will take approximately two to three weeks to complete these technical adjustments.

MLLP cannot predict precisely the number of viewers who will temporarily lose access to KAYU-TV's programming service when it completes its transition to DTV Channel 28. However, based on available data, its knowledge of the Spokane, Washington television market and the surrounding areas, and the cable systems that carry KAYU-TV, MLLP reasonably

believes that more than 200,000 people will potentially be adversely affected. These viewers have come to rely on KAYU-TV's local news and emergency programming to keep them informed of severe weather conditions at this time of year, including lightning, wildfires and tornados. Indeed, KAYU-TV's EAS system was activated as recently as July 28th to alert viewers in areas served by several of the above-referenced translators to seek immediate cover following a National Weather Service tornado warning. Any interruption to KAYU-TV's vital emergency information service would be contrary to the public interest.

For the reasons set forth herein, MLLP respectfully requests an STA to permit KAYU-TV to continue operating on its pre-transition DTV Channel 30 for a period of 30 days following the initiation of program tests on DTV Channel 28.

Also enclosed is a completed FCC Form 159 for the credit card payment of the applicable \$170.00 filing fee and an executed Anti-Drug Abuse Certification.




