Markets 1, 2, and all remaining newly created markets with the exception of Market 3 are common to station WKYQ (FM). Since WKYQ (FM) overlaps 26 other stations not proposed for common ownership, the Applicant can own up to 6 stations, with four in one service.

The FM stations that overlap contours with WKYQ (FM) are: KEZS, KGMO, WCBL-FM, WGKY, WFGE, WRIK-FM, WMJL-FM, WZZL, WOOZ-FM, WREZ, WVVR, and WCKK.

The AM station contours that overlap WKYQ (FM) are: WBCE, KCHR, KZIM, WKRO, WYMC, WCBL, WNBS, WRKY, WMOK, WMJL, WWLK WNTX, WKDZ, and WGGH.

Market 1 is defined by the following stations proposed for common ownership, WKYQ (FM), WDDJ (FM), WLIE-FM, WKYX (AM), WDXR (AM) and WPAD (AM). Three FM and three AM stations.

Market 2 is defined by the stations proposed for common ownership WKYQ (FM), WDDJ (FM), WLLE (FM), WKBG (FM), WPAD (AM) and WKJM (AM). Four FM and two AM stations.

Market 3 is defined by two FM stations, WKBG (FM) and WLLE (FM) and overlap with 18 other stations not commonly owned. Since these stations overlap with 18 other stations that are not commonly owned, the Applicant could own up to six stations with four in one service.

The FM stations that overlap with WKBG (FM) and WLLE (FM) include: WCBL-FM, WGKY, WFGE, WRIK-FM, WZZL, WREZ, WQAK, WWKF, WYVY,

The AM station contours that overlap with WKBG (FM) and WLLE (FM) are: WKZT, WBCE, WYMC, WCBL, WNBS, WRKY, WMOK, WWLK, and WNTX.

Conclusion:

The proposed common ownership of stations discussed herein does meet 47 C.F.R. Section 73.3555(a) of the Commission's Rules since this report and attachments show that the stations proposed for common ownership does not exceed the maximum multiple of stations allowed by the Commission's Rules in each and every newly created market.

The stockholders, members, or officers of the Applicant do not hold ownership in any other station with a contour that overlaps with the stations discussed herein as proposed for common ownership.

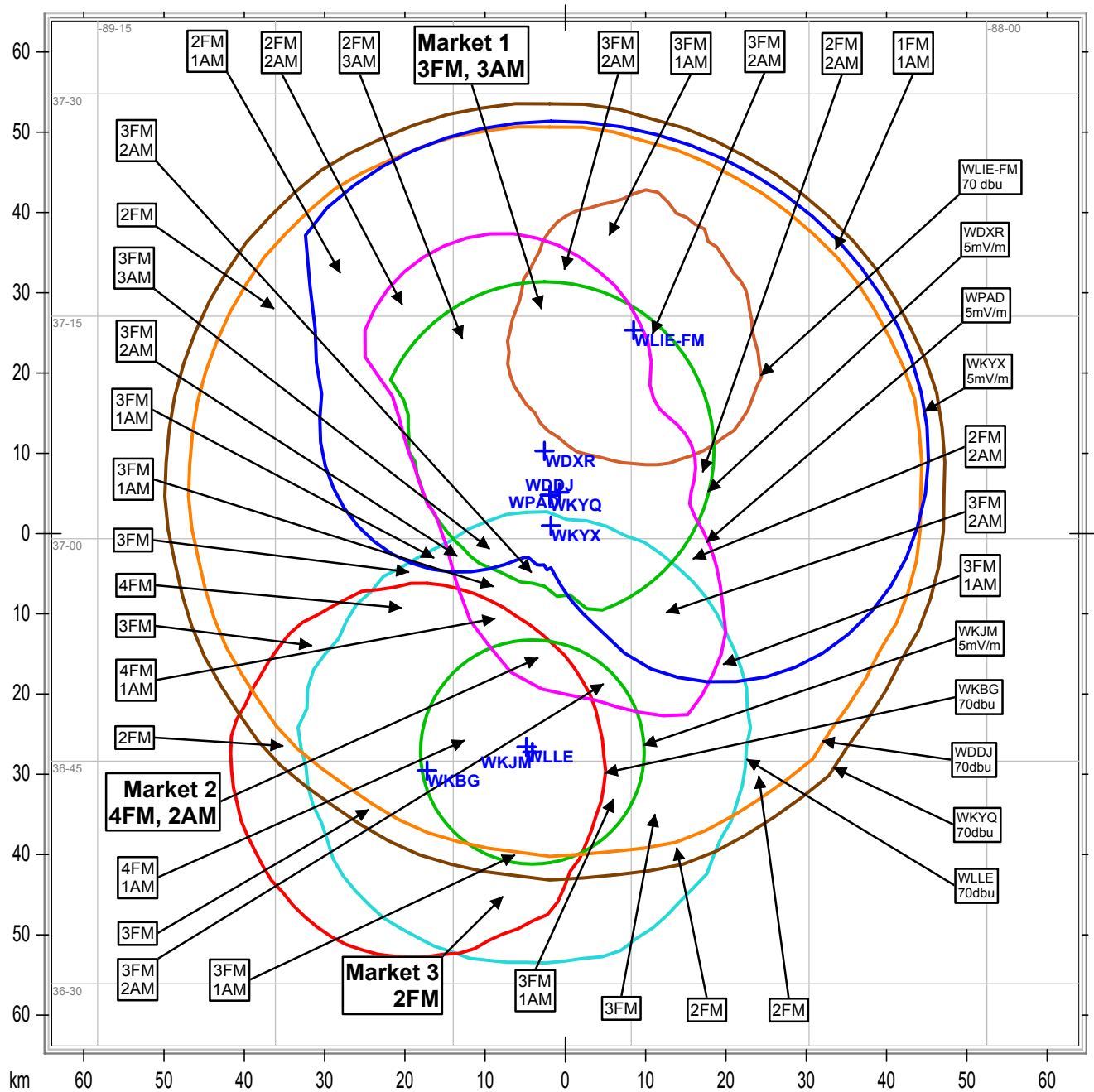
