

**OTHER BROADCAST INTERESTS**

Univision Communications Inc. ("UCI") is a publicly-traded company, and no single person or entity holds 33% or more of the debt/equity of the company. A. Jerrold Perenchio is the single majority shareholder, voting 69.08% of the stock of UCI, by virtue of the fact that his Class P common stock is entitled to 10 votes per share so long as he continues to own at least 30% of the shares he held on October 2, 1996.

Grupo Televisa, S.A. and Venevision International Ltd. are shareholders organized under the laws of foreign countries which are represented by a director on the UCI Board of Directors. Jose Baston Patino is the Televisa director and Alejandro Rivera is the Venevision director. In addition, each entity holds certain warrants, which would allow it to increase its stock holdings to the extent that it is lawful for such a foreign entity to do so. In approving UCI's application on FCC Form 316 with respect to UCI's reorganization and offering of Class A Common Stock in 1996 (FCC File Nos. BTCCT-9606281ID through BTCCT-9606281IN and BTCCT-960628IP through BTCCT-960628IV), the Commission approved this ownership structure. *See also Univision Holdings, Inc.*, 7 FCC Rcd 6672, 6673-74 (1992).

UCI wholly owns PTI Holdings, Inc. ("PTI"), which in turn wholly owns Univision Television Group, Inc. ("UTGI"). UTGI is the controlling general partner and PTI is the non-controlling general partner of the following licensee partnerships, which are the licensees of the indicated broadcast stations:

UTGI is also an applicant for a new television station on Channel 52 at Blanco, Texas. UTGI is also the proposed assignee of Class A television station KZZA-LP, Flagstaff, Arizona. See FCC File No. BALTV-20010614AJW.

UCI is the 100% shareholder of Univision Acquisition Corp. ("UAC"). UAC is the ultimate parent of the licensees of three television stations transferred from USA Broadcasting, Inc. Specifically, UAC is the 100% shareholder of USA Station Group of Hollywood, Florida, Inc.; USA Station Group of Atlanta, Inc.; and USA Station Group of Dallas, Inc. USA Station Group of Hollywood, Florida, Inc. is the sole member of Miami Station LLC. USA Station Group of Atlanta, Inc. is the sole member of Atlanta Station LLC. USA Station Group of Dallas, Inc. is the sole member of Dallas Station LLC. USA Station Group of Hollywood, Florida, Inc. holds a 99% general partnership interest and Miami Station LLC holds a 1% managing general partnership interest in USA Station Group Partnership of Hollywood, Florida, licensee of WAMI-TV, Hollywood, Florida. USA Station Group of Atlanta, Inc. holds a 99% general partnership interest and Atlanta Station LLC holds a 1% managing general partnership interest in USA Station Group Partnership of Atlanta, licensee of WHOT-TV, Athens, Georgia. Finally, USA Station Group of Dallas, Inc. holds a 99% general partnership interest and Dallas Station LLC holds a 1% managing general partnership interest in USA Station Group Partnership of Dallas, licensee of KSTR-TV, Irving, Texas.

In addition, UCI is the proposed transferee of the stock of several wholly-owned subsidiaries of USA Broadcasting, which collectively operate ten additional television stations

which have not yet been transferred. See FCC File Nos. BTCCT-20010123AAL, BTCCT-20010123AAM, BTCCT-20010123AAN, BTCCT-20010123AAP, BTCCT-20010123AAR, BTCCT-20010123AAS, BTCCT-20010123AAU, BTCCT-20010123AAV, BTCCT-20010123AAW, BTCCT-20010123AAX.

Certain officers and directors of UCI also hold positions as officers and directors of UCI subsidiaries PTI, UTGI, UAC and its subsidiaries.

UCI also holds 21,983,392 Class C and 14,942,931 Class A shares of Entravision Communications Corporation ("Entravision"), which represent approximately 32% of the outstanding stock of that company. Entravision, through various subsidiaries, owns and operates multiple radio and television stations. Specifically, Entravision is the parent of Entravision Holdings, LLC ("EHL"), the licensee or permittee of the following stations:
