**THIRD SUPPLEMENT TO
JOINT REQUEST FOR APPROVAL OF SETTLEMENT AGREEMENT
AND REQUEST FOR GRANT OF APPLICATION**

St. Joseph's Catholic School, Inc. (SJCS) and Community Broadcast Services (CB), by their respective attorneys, hereby respectfully submit this Third Supplement to their December 14, 2012 "Joint Request for Approval of Settlement Agreement". In so doing, the following is shown:

1. Attached hereto is a Declaration under penalty of perjury executed by CB's consulting engineer, Michael D. Brown, of Brown Broadcast Services, Inc., Portland, Oregon, stating that his firm provided technical consulting


services to CB "during 2007 to 2009" relative to the preparation, filing and prosecution of CB's application at Laurens, South Carolina. Mr. Brown states that "the total billed amount for those services was \$3943.80, which has been paid in full".

2. Therefore, the parties hereto respectfully request that the FCC authorize SJCS to pay CB a total of \$8,026.80, which is the sum of \$3,943.80 incurred by CB with Mr. Brown's firm and \$4,083.00 incurred by CB with attorney Michael Couzens which has been previously documented.

WHEREFORE, it is urged that (1) their Joint Request for Approval of Settlement Agreement **BE GRANTED** and expense reimbursement by SJCS to CB in the amount of \$8,026.80 **BE ALLOWED**; (2) the application of Community Broadcast Services for a new NCE FM Station at Laurens, South Carolina (File No. BNPED-20071018AMP) **BE DISMISSED**; and (3) the application of St. Joseph's Catholic School, Inc. for a new NCE FM Station on Channel 213 at Gray Court, South Carolina (File No. BNPED-20071022BHF) **BE GRANTED**.
