#### ANSWER TO FCC FORM 316 SECT. III ITEM 5a: CHANGES IN INTERESTS AS RESULT OF TRANSFER OF CONTROL

Board bylaws specify a minimum of 14 members and a maximum of 38. Each Board member has one vote, except for Barbara Vacarr, who is President of applicant Goddard College Corporation "GCC" and a nonvoting member of its Board of Directors. All Board members, current and former, are U.S. citizens.

GCC is a non-stock, non-profit organization. GCC is filing this application to obtain Commission consent to new members of its Board of Directors. The selection of GCC's new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in Board membership. This application is provided for FCC approval of the Board after 50% of the members of the board of directors have changed.

The Board Members during each of the years from 2011, when the Commission last granted an application for transfer of control of the licensee (BTCED - 20111223AAB granted December 23, 2011), are set forth in the chart below.

No consideration or other thing of value is being given in exchange for the interests being transferred. No Board Member has broadcast interests other than in WGDH and WGDR.
