

Statement regarding occupations
of proposed members of governing board

Babbie Mason is a self-employed singer, song writer, author and TV performer on her own syndicated program.

She has resided in the Atlanta area for 24 years. Included in her credentials are those in the following FCC categories of community life:

(6) Culture: She has sponsored an annual music seminar in Atlanta for the past 13 years. She is a recording artist whose records and albums are distributed under the Spring Hill label. She also is an author with two published books. Her weekly syndicated television program, Babbie's House, produced at the studios of WATC, currently in its sixth season, is a showcase for local singers, dancers, musicians and authors. Examples of Atlanta guests of this nature include recording artists Vernessa Mitchell and Candi Station; the Atlanta Festival Chorus and the big band sound of Dave Boyer; author Donna Douglas; comedienne Anita Renfroe and performances by members of the cast of Adam's Rib.

(7) Education: She is a former teacher and currently a guest university lecturer.

(12) Minorities and Ethnic Groups: She is African American. She produced a one hour video and CD "Treasured Memories: A Celebration of Our Gospel Music Heritage" honoring black gospel music. Interview guests on her television show include financial expert Lee (Taking Care of Business) regarding financial issues that many African Americans face; radio personality Jennifer Keitt (Today's Black Woman Radio Show); a discussion with Teresa Kemp of the Underground Railroad Quilt Code, in which the pattern of the quilt informed those in flight where to go for safety.

Joe Oreskovich is the founder and President of a nonprofit entity to provide help for needy persons addicted to drugs or alcohol, or threatening suicide.

He has resided in the Atlanta area 34 years. He struggled with addictions in his own life, leading to a period of homelessness on the streets of the city. A firefighter was instrumental in persuading him to voluntarily surrender to police for outstanding warrants and turn his life around. He was also helped by a detention officer during his tenure in the DeKalb County jail. He has since devoted his life to helping others and to promote the interests of the firefighters and the police. Included in his credentials are those in the following categories of community life:

(2) Business: He was an insurance salesman in Atlanta for 20 years.

(3) Charities: He works with various charitable organizations in Atlanta, such as participating in a Christmas outreach for terminally ill children.

(4) Civic, Neighborhood and Fraternal Organizations: Mr. Oreskovich is a member of Full Gospel Businessmen and the Norcross Fellowship Luncheon. He works closely with the Metro Fire Chiefs.

(5) Government: He began working with police and firefighters in the late 1990's to establish memorials for fallen comrades. He wrote a 20-year pension plan for firefighters and police officers for the State of Georgia. He has testified at the State Capitol in support of legislation in their interests. After losing his insurance license and job during his period of illness and homelessness, he has now been named a State Fire Marshall by the Georgia Insurance Commissioner. He has received other honors from the State Police, the Georgia Bureau of Investigation and the State Bar of Georgia.

(10) Labor: He has worked with the Georgia Department of Labor to develop a television program for WATC on "Putting Georgia Back to Work."

(11) Military: He served in the U.S. Army for a two-year period shortly (this was shortly before moving to Atlanta in 1970).

(17) Public Safety, Health and Welfare: He played a part in developing a "Public Servant Hotline" which has been credited for helping more than 180 people get into recovery programs from drugs and alcohol and aborting more than 30 suicide attempts.

Vernon Klaudt is a retired school principal and teacher.

He has resided in the Atlanta area for approximately 55 years. Included in his credentials are those in the following categories:

(6) Culture: He is a member of the Klaudt Indian Family music group founded by his parents that has performed at the Atlanta Braves Stadium, the Grand Ole Opry, the Kennedy Center in Washington, and elsewhere including Indian reservations. Jimmy Carter, when governor, proclaimed the Klaudt Indian Family "ambassadors of good will."

(7) Education: He attended four universities in the Atlanta area, i.e., Emory University, Oglethorpe University, Georgia State University and the University of Georgia. He earned a liberal arts degree from Oglethorpe, a Master's degree in teaching and a second Master's degree in school administration, both from the University of Georgia. For 20 years Mr. Klaudt was

a teacher and principal in the Atlanta area, i.e., a teacher and assistant principal at Norcross Elementary School in Norcross, an assistant principal at Lawrenceville Elementary School in Lawrenceville, principal of the Five Forks Middle School in Snellville, and principal of Mt. Paran Christian School in Atlanta.

(12) Minorities and Ethnic Groups: Mr. Klaudt is a Native American who maintains active ties to this heritage, i.e., the Plains Indians in the Dakota Badlands of Northwest America, the original home of the Arickara-Mandan Indians. His great grandfathers, One Feather and Little Soldier, fought in Custer's battle in 1876 at the Little Big Horn River in Montana as scouts for the U.S. Cavalry; Mr. Klaudt's Indian name is Chief Little Soldier.

(19) Religion: Mr. Klaudt earned a divinity degree from Emory University and for a period of time was one of the associate pastors at the Mt. Paran Church of God in Atlanta, a congregation with over 17,000 members.

Bobby Hurd is owner and chief executive officer of Bobby Hurd and Company, Inc., an electrical contractor. He has resided in the Atlanta area for 38 years. Included in his credentials are those in the following categories:

(2) Business: Mr. Hurd began work as an electrician and founded the Bobby Hurd and Company, which has become a highly successful electrical contracting business in the City of Atlanta dating back 30 years to 1972. He has been recognized in the national "Who's Who in Executives and Professionals."

(4) Civic, Neighborhood and Fraternal Organizations: He has been a committee chairperson for projects honoring Martin Luther King, Jr.. He is involved in the Dekalb County Chapter of the NAACP and has received honors from that organization for his work. He has been a member of Dr. King's organization, Southern Christian Leadership Conference (SCLC), since 1974.

(10) Labor: Dr. King recognized the value of community servants. He came to their aid and led a rally in Memphis, Tennessee, on behalf of sanitation workers. This year, Mr. Hurd is recognizing that memory with a project to honor sanitation workers in Atlanta.

(12) Minorities and Ethnic Groups: Mr. Hurd is African American. He came to Atlanta at an early age from the Mississippi cotton fields. He attended South Fulton High School and Atlanta Area Tech, both in Atlanta.

James Thompson is a television executive and TV air personality.

He has been a part-time resident of the Atlanta area since WATC commenced operations in 1996. Since the very beginning of station operations, WATC has originated a two-hour live program Monday through Friday in prime time evening hours (Atlanta Live); generally, Mr. Thompson has traveled to host that program one night a week,¹ hosting approximately 150-200 programs since 1996. Usually, several guests appear on the program each evening. Accordingly, Mr. Thompson has interviewed on the order to 500 guests over the past approximately eight years, providing the opportunity to meet and interview a very substantial number of Atlanta area people reflecting various walks of life.²

Joanne Thompson is a homemaker and television personality. She has been a part-time resident of the Atlanta area since 1996 and has also traveled there generally on a weekly basis to host Atlanta Live on a different night than when her husband hosts the show. Accordingly, what has been said above regarding the opportunity of Mr. Thompson to gain insights into the needs and interests of Atlanta applies equally to Mrs. Thompson.

Gene Bechtel is a Washington-based communications attorney for WATC. He brings to the board experience with legal aspects of nonprofit educational broadcasting acquired in representation of clients including, for approximately 15 years, the Georgia State Public Telecommunications Commission and its many broadcast stations, headquartered in Atlanta to which he traveled in that work, and, for approximately 10 years, the Public Broadcasting Service, headquartered in Alexandria, Virginia, in certain regulatory matters before the FCC and certain copyright and program licensing matters before the Copyright Office and the Copyright Royalty Tribunal.

¹ His principal residence in Greenville, South Carolina, is located approximately 140 miles from Atlanta, connected by an interstate highway, roughly equivalent to travel from Washington to Ocean City or Rehoboth Beach.

² A summary of guests on Atlanta Live reflecting the 19 categories of community life identified by the FCC as a checklist for members of a governing board is attached. While WATC is not claiming that Mr. Thompson, himself, is an Atlanta area community leader under any of these categories, his multiple and continuing appearances on Atlanta Live have provide greater insight and sensitivity to the make up and needs of the greater Atlanta community than would be true for an absentee non-resident member of the governing board.

COMMUNITY ELEMENT CATEGORY # 1 - AGRICULTURE

George Harris of the Center for Family Farm Development of Atlanta, GA discussed the work of the center.

Summary: This category is seldom addressed during Atlanta Live, due to the metropolitan nature of the coverage area of WATC.

COMMUNITY ELEMENT CATEGORY # 2 - BUSINESS

Colleen Reiter of the International Mentoring and Entrepreneurial Center of Atlanta discussed the importance of mentoring young people in business.

As part of the "Putting Georgia Back To Work" program, Bob Rogers, President of Quantum Executive Search of Atlanta, shared tips on how to find employment.

Businessman Gene Swindell of Creative Concepts International of Roswell, GA discussed his start in the business world and offered encouragement to other career-oriented individuals.

Holly Beauchamp of B-Champs of Roswell, GA shared tips from her safety seminars geared to business and corporate individuals.

Robert Watkins, founder of Kings and Priests Unlimited of Lithia Springs, GA, shared about the monthly meetings held by the organization for businessmen and government officials.

Summary: Due to the non-commercial nature of WATC, Atlanta Live limits the amount of business-oriented topics during the program. There are other programs featured on WATC that address business topics with greater frequency.

COMMUNITY ELEMENT CATEGORY # 3 - CHARITIES

Elizabeth Omilami visits annually to discuss the work of Hosea Feed The Hungry and Homeless of Atlanta, GA. The group feeds several thousand individuals in need very Thanksgiving and Christmas at Turner Field in Atlanta. Also featured in other appearances with Hosea Feed The Hungry were staff members Charlotte Hazard, Amos Brown and Shealeta Murden.

House of Hope Founder Gloria Harrell of Roswell, GA shared on the work of the organization which offers counseling, support groups and transitional housing to those in need.

Ed Butchart and David Stone of Friends of Disabled Adults and Children Too of Stone Mountain, GA discussed the work of the organization and how they offer support to the disabled.

Captain Steve Morris of the Atlanta branch of the Salvation Army shared about its Christmas outreach and presented the Salvation Army Atlanta Temple Songsters.

Guests representing the Georgia Coalition on Donation appeared to encourage organ donation. National board member Chaplain Skip Wisenbaker shared along with Ann Sechrist who donated her son's organs.

Greg Becker represented a March of Dimes event called "Saving Babies Together" that took place in Atlanta, GA

Joe, Wes and Andy Wingo of Angel Food Ministries discussed the work of the organization and how many needy families have been blessed by the outreach.

Summary: Atlanta Live presents approximately fifty various non-profit charities per year on the program. Some are community-based and others are ministry-based.

COMMUNITY ELEMENT CATEGORY # 4 – CIVIC, NEIGHBORHOOD & FRATERNAL ORGANIZATIONS

Karen Beavor of the Georgia Center for Nonprofits discussed the work of the organization in providing resources to various organizations throughout Georgia.

Marvin Cannon, Director of FCS Community Economic Development in Atlanta, shared about the latest in the revitalization of areas of Fulton County.

Jan Kennedy of the Gwinnett Ministries Network discussed the work assisting needs in Gwinnett County (part of Metro Atlanta).

Randy Haviland of UniteAtlanta appeared on the program to talk about the local ceremonies and memorial services planned in remembrance of the events of September 11.

Geffry Tate of Community Reach, Inc. of Riverdale, GA shared on the afterschool program to the children of the Riverdale area and the need for more volunteers.

Anita Weems of the Atlanta Project for Children at Risk located in Douglasville, GA shared about the work of the organization.

Chip Sweney, Community Outreach Director of Perimeter Church of Duluth, GA, talked about the transitional housing program to help women and children in need and the other projects he oversees.

Cammie Barnes and Sharena Summerall of the American Red Cross of Atlanta talked about the need for blood donations.

Citizens for Community Values Executive Director Eli McKenzie; Board Chairman Tony McLellan; and Office Manager Beverly Miles shared about the work of the organization. Also appearing was Victim Assistance Program Coordinator Claire Hertzler.

Founder and Public Speaker Fred "V-Man" Watson and Regional Health Administrator Tom Carrato with Victory Over Violence of Atlanta, GA shared about their work in the inner city communities.

Summary: Atlanta Live presents approximately twenty-five various civic organizations per year. Many of these groups make multiple appearances during the year.

COMMUNITY ELEMENT CATEGORY # 5 – CONSUMER SERVICES

Financial expert Michael Grayson of Perfect Credit Score of Atlanta shared on ways individuals can improve their credit and finances.

Sharon Cabeen, Director of Education of Consumer Credit Counseling Service of Atlanta presented financial tips for consumers to improve their household budgets and improve their credit standings.

Calvin King, Financial Aid Counselor, represented the Georgia Student Finance Commission on various ways to obtain funds for college.

Feed My Lambs Founders Kells and Elizabeth Weatherby of Atlanta, GA presented stories from their work with pre-school children and other projects assisting children in Georgia and beyond. Other Feed My Lambs representatives appearing included Kells Weatherby, Jr., Blake and Rachel Weatherby, Carla Northcutt, and Kelly Falany.

Students Angela Hering and Nina Blackmon of Beulah Heights Bible College of Lithonia, GA shared on their experiences at the college.

Rev. Robert Crummie of Carver Bible College of Atlanta shared about the school and his personal vision for the school.

Russ Breault of the Shroud of Turin Educational Project of Peachtree City, GA talked about his findings while researching the Shroud of Turin and presented portions of his lecture presentation.

Larry and Carol Chkoreff, Founders of the International School of the Bible of Marietta, GA and Beauty Baldwin, Administrator of Hopewell Christian Academy of Norcross, GA were featured discussing the educational programs available at their schools.

Dr. James Flannagan, President of Luther Rice Bible College and Seminary of Lithonia, GA, shared about the goals of the college in training spiritual leaders.

Summary: WATC is licensed as a non-commercial educational station and features numerous guests from educational institutions every year. In addition, WATC features many guests, mainly pastors and evangelists, who present Bible lessons every week but were not featured in those names listed above.

COMMUNITY ELEMENT CATEGORY # 8 – ENVIRONMENT

Summary: While an important topic to WATC, the station does not include guests representing this category in its *Atlanta Live* program. Other programming on the station addresses this topic.

COMMUNITY ELEMENT CATEGORY # 9 – GOVERNMENT

Georgia State Senator Donzella James (District 35) of Atlanta appeared to talk about the latest issues being addressed in the State Senate.

Judge Walter J. (Jim) Clark of the Probate Court of Gwinnett County located in Lawrenceville, GA discussed issues pertaining specifically to the elderly.

Chaplain Kevin Lewis, Chaplain of the Atlanta Police Department in Atlanta discussed his work with law enforcement officials.

Tom Fox, City Manager of Porterdale, GA and Officer Clenton Fowler of the Porterdale Police Department talked about their work.

Ken Duke, Director of the Gwinnett Department of Family and Children Services, talked about what the organization does to insure the safety of children in volatile living situations.

Summary: WATC features other original programming on the station that addresses this topic more frequently than presented on *Atlanta Live*.

COMMUNITY ELEMENT CATEGORY # 10 – LABOR

Joe Oreskovich and Robbi Warren appeared on a special edition of *Atlanta Live* on "Putting Georgia Back To Work" which also featured Pat Veal, Employment Marketing Representative of the Georgia Department of Labor; Steve Lee, Executive Director of Unity Network and Counseling Center of Atlanta, GA; and Job Fair coordinator Amy Wright of Fairburn, GA

Roderick Wyatt, Manager of the North Metro Career Center for the Georgia Department of Labor in Atlanta discussed the latest facts and figures on unemployment and offered suggestions on how to find employment.

Summary: "Putting Georgia Back To Work" is regularly featured on WATC in other original programming in addition to *Atlanta Live*.

COMMUNITY ELEMENT CATEGORY # 11 – MILITARY

U.S. Marines Chief Warrant Officer Joe Galvanga appeared to talk about the Marines involvement in the annual Toys For Tots drive in Atlanta, GA.

Summary: While many guests appearing on *Atlanta Live* have been in the military and may share parts of that experience in their stories, there are only a few who have appeared on the program specifically representing the military. WATC features military guests and public service announcements during other programming.

COMMUNITY ELEMENT CATEGORY # 12 – MINORITY AND ETHNIC GROUPS

Byron Cooper, Publisher of MC Magazine of Marietta, GA, shared about the focus of the magazine in uniting the races.

Rabbi Robert Solomon of Beth Hallel Messianic Congregation of Roswell, GA shared along with Dorothy Solomon, Executive Director of the Messianic Jewish Israel Fund. Also appearing from Beth Hallel were Gary Price, Lynne Schultz, Alan David and Eric and Lara Walker.

Jean Sewell presented selections from The Reunion Mass Choir of Athens, GA celebrating the heritage of black gospel music.

Sophia Esquivel of Decatur, GA announced the upcoming Heritage Arts Festival, highlighting music, dance and the arts.

Pastor Jose Da Silva of the Sandy Springs Brazilian Assembly of God of Atlanta, GA discussed the ministry outreach to the Brazilian community in Georgia.

President Beverly Rhodes and Director of Communications India Pullin of Shades of Color: A Humor Ministry presented their vision and goal to bridge the racial gap through humor.

Summary: *Atlanta Live* presents sharing guests, hosts and musical guests from a wide variety of cultural backgrounds. Approximately 50% of the guests featured on *Atlanta Live* are African American.

COMMUNITY ELEMENT CATEGORY # 13 – ORGANIZATIONS FOR ELDERLY

Annie Copeland, Senior Friends Coordinator and Director of Volunteer Services of Eastside Senior Friends of Snellville, GA talked about their work for seniors. Also sharing were Eastside Senior Friends volunteers Pat Dixon, Don Shiver, and Marian Kane.

Miss Mary Lawson celebrated her 90th birthday on the air and representatives from WATC's First Works Outreach discussed their work with the elderly.

"Seniors Today" edition of *Atlanta Live* featured Officer Tim Colgan of the Snellville Police Department of Snellville, GA discussing crimes against the elderly and Elder Care Advisor Phillip Sanders, CPA discussing financial matters that affect seniors.

Second Wind Dreams Founder P.K. Beville of Atlanta, GA appeared on the program to discuss the work of the organization in making dreams

come true for seniors. Additional guests included volunteers Chris Wrenn and Pat Wurster and dream recipient Laura Greeson.

Summary: Topics dedicated to senior citizens are routinely featured in a special two-hour edition of *Atlanta Live* presented monthly.

COMMUNITY ELEMENT CATEGORY # 14 – ORGANIZATIONS FOR WOMEN

Founder Evangelist Gloria Watkins, teachers Gwendolyn Sims and Rosetta Clark and prayer intercessor Pastor Sherry White of Shepherd's House: A Transitional Home for Ladies of Athens, GA shared about their work in helping women restore their lives.

Steve Schiffman, founder of The Hope Project, sharing on the goals of the organization to provide computer training for women to become self-sufficient.

Villiera Spearman and Francis Browning of the Mary Hall Freedom House for Recovering Women in Atlanta discussed the work of the center and the success stories in helping women to overcome adversities in life.

Johnnie Gaskins of Johnnie's House of Austell, GA shared on the work helping battered women with housing and emotional support.

Rev. Lonnie Cunningham and Benetta Smith of Door of Hope Women's Ministries of Felton, GA discussed the work to aid women.

Carolyn Jenkins and Michele Jordan of Women of Vision International Ministries of Decatur, GA discussed their recent projects for aiding and encouraging women.

Clara Walton of Bosom Buddies of Georgia in Chamblee, GA discussed the work of the women's cancer support group.

Summary: Topics pertaining to women are a regular feature on *Atlanta Live*. On average, there is one women's organization featured each week.

COMMUNITY ELEMENT CATEGORY # 15 – ORGANIZATIONS FOR YOUTH

Coach Ken Woods of Coach Speaks of Norcross, GA talked about this work with teens regarding drugs, alcohol and violence.

Be Someone Founder Orrin Hudson of Atlanta, GA appeared to discuss the organization's work to educate and inspire today's youth.

Coach Dennis Clark of Jumping for Jesus of Buford, GA demonstrated various jumping techniques and talked about the fitness program he presents to schools and church youth groups.

Jeff Miller of Teen Force Ministries of Social Circle, GA talked on issues affecting today's teens. Teens Luke James, Sharonrose Fetzer, Matt Coffman and Nick Coffman also shared.

Jeff Seigel of the Global Youth Baseball Foundation of Lawrenceville, GA shared on his work with the youth here in Georgia and around the world.

Atlanta Youth Academy representatives Larry Teem, James Daniel, Terrell Gilbert and Chuck Johnson shared throughout a two-hour edition of *Atlanta Live*.

Tim and Barbara Newbon and Ryan Westover and Eli Anderson of Teen Challenge in Lithonia, GA discussed the work of Teen Challenge and shared personal stories on how it has affected their lives.

Local groups reaching today's youth were featured, including Steve Wiegand of Kids and Teens 519 of Atlanta, GA and Kenneth and LaWanda Law of Kingdom Kids Fitness of Stone Mountain, GA.

Charles and Barbara Kendrick-Holmes of Camp Maranook shared about the summer camp and how teenagers have life changing experiences at the camp. Parents Lee and Wendy Williams of Atlanta, GA share their own story about their teen.

Flat Shoals Family Life Center was the focus of a program featuring guests Director Michael Mays, Board President Herman Williams and Coach Sharman White from Carver High School.
