TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Regent Broadcasting of Evansville/Owensboro, Inc. ("Regent"), proposed assignee of WGBF, 1280 kHz and WJLT, Channel 287B, Evansville, Indiana; WGBF-FM, Channel 276A and WKDQ, Channel 258C0, Henderson, Kentucky; WDKS, Channel 291A, Newburgh, Indiana; and WOMI, 1490 kHz and WBKR, Channel 223C, Owensboro, Kentucky.

2. WGBF, WJLT, WGBF-FM, WKDQ and WDKS are each licensed to a community in a metro county in the Evansville, Indiana Arbitron Market (Market #163). WOMI and WBKR are not licensed to a community in a metro county in any Arbitron Market and are not designated "home" in any market. WOMI and WBKR have overlap of city grade contours with one or more of the Regent metro facilities. As a result, a hybrid ownership analysis is necessary to demonstrate compliance in both a rated and non-rated market.

EVANSVILLE, INDIANA ARBITRON/BIA MARKET REVIEW

3. As shown on Exhibit #1, there are twenty-four AM and FM (commercial and non-commercial) stations listed in the Evansville, Indiana Market. Regent would be in control of four FM stations and one AM station in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, control of WGBF, WJLT, WGBF-FM, WKDQ and WDKS in the Evansville, Indiana Market is believed to be in compliance with the Commission's radio ownership rules for rated markets.

REVISED CONTOUR OVERLAP ANALYSIS

4. A study has been conducted to verify that the proposed control of the above referenced stations is also in compliance with the Commission's revised contour overlap rules. The city grade contours of the subject stations are shown on Exhibit #2. The locations of the city grade contours of these stations create two distinct markets. Market #1 consists of AM station WGBF and FM stations WDKS, WJLT, WGBF-FM, WKDQ and WBKR. Market #2 consists of AM stations WOMI and WGBF and FM stations WKDQ and WBKR.

5. A study, therefore, has been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. Since the contours of WKDQ and WBKR are subject stations in both markets, these city grade contours (defined as the Radio Market

Boundary) were used to determine the number of other commercial and non-commercial AM and FM stations that either have transmitter sites within or provide coverage to the radio market. The relative subject stations will then be added to determine the number of stations in each of the two defined markets. Only those stations with transmitter sites within 92.0 kilometers will be considered as contributors to the market. No other station in which Regent has an interest will be considered, unless it is a subject station in the market under review.

6. Exhibit #3 is a depiction of the stations within, or providing service, to the WKDQ-WBKR/Radio Market boundary. There are a total of forty-one other stations which are considered contributors to the WKDQ/WBKR market. Exhibit #4 is a tabulation of the stations in Radio Market #1, which totals forty-seven when the six subject stations are included.¹ The number of stations depicted falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At the forty-five or more stations level, common ownership or control of up to eight stations, with no more than five in the same service. As such, Market #1 is in compliance with the rules.

7. Exhibit #5 is a tabulation of the stations in Radio Market #2, which totals forty-five when the four subject stations are included. The number of stations depicted also falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this same level, common ownership or control of up to eight stations, with no more five in the same service, is permissible. As such, Market #2 is in compliance with the rules.

1) There are additional stations contributing to the market, but they were not considered as there was a sufficient number to demonstrate compliance based on the number of stations to be commonly held.

8. Therefore, common control of WGBF, WJLT, WGBF-FM, WKDQ, WDKS, WOMI and WBKR, in the pertinent rated and non-rated markets, by Regent is in compliance with §73.3555 of the rules.

9. The foregoing technical statement was prepared on behalf of Regent Broadcasting of Evansville/Owensboro, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.5. BIA database. All other data was extracted from the CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.
