

## OWNERSHIP STRUCTURE OF ASSIGNEE

Mapalé LLC, a Delaware limited liability company ("Mapalé"), the proposed assignee in the instant application, is owned and controlled as follows.

The equity and voting control of Mapalé is held solely by Cumbia Entertainment LLC, a Delaware limited liability company ("Cumbia"). Wepahe Entertainment LLC, a Delaware limited liability company ("Wepahe"), holds 50% equity and voting control of Cumbia. Caracol TV America Corp, a Delaware corporation ("Caracol Corp."), holds 25% equity and voting control of Cumbia. Sonia Broadcasting Company, LLC, a Delaware limited liability company ("Sonia"), holds 25% equity and voting control of Cumbia.


Alejandro Santo Domingo, a United States citizen, holds all equity and voting rights in Wepahe. Caracol Televisión S.A., a Colombian company which is publicly traded in Colombia ("Caracol SA"), holds all equity and voting rights in Caracol Corp. The "Community Property Trust" is a 50% member of Sonia. William C. De La Peña, M.D. and Robin De La Peña are equal co-trustees of that trust. The "Husband's Separate Property Trust" is a 50% member of Sonia. William C. De La Peña, M.D. is the sole trustee of that trust. Robin De La Peña and Dr. William C. De La Peña are both United States citizens.

### Non-Attribution Statement

With the exception of Alejandro Santo Domingo (a United States citizen) and Paulo Laserna, none of the directors, officers or shareholders of Caracol SA will exercise authority or influence in the management or control of Mapalé or its licensed stations.

In addition, all persons and entities with attributable interests in Mapalé are United States citizens or entities, with the exception of Paulo Laserna and Caracol SA, as described above. The governing formation and operational documents of Cumbia, the sole owner of Mapalé, prohibit alien ownership or control in excess of 25%.

### Other Media Interests

Mapalé and the individuals and entities in its ownership structure have no attributable interest in any broadcast station or other media of mass communication other than the proposed acquisition of the stations listed in this exhibit, except that Alejandro Santo Domingo holds a 75% equity and voting interest in El Dorado Broadcasting Corporation, the sole owner of WSUA Broadcasting Corporation, the licensee of WUSA(AM), Miami, Florida, ID 55403. He is the president of both of those companies.

The other media interests of Sonia are set forth in the assignor's section of this application (Exhibit 5).

### Family Relationships

Robin De La Peña and William De La Peña are married to each other. Alejandro Santo Domingo and Andres Santo Domingo are brothers and Julio Mario Santo Domingo Rechulsky is their nephew.
