³ Mr. Bryan holds both Class B and Class A shares either directly or through various trusts, including the D. Tennant Bryan Media Trust (the “Media Trust”) of which Mr. Bryan is the sole trustee. Pursuant to the shareholder voting rights and restrictions set forth in the company’s Articles of Incorporation, Mr. Bryan controls the Board of Directors and the company and is the single majority shareholder of Media General, Inc. within the meaning of Section 73.3555 of the Commission’s rules by virtue of the Class B shares he holds directly and through the Media Trust. Accordingly, pursuant to the Commission’s *Memorandum Opinion and Order* (“MO&O”) in MM Docket Nos. 94-150, 92-51, and 87-154 (released January 19, 2001) ¶ 44, the interests of Media General, Inc.’s greater-than-five-percent minority shareholders which were acquired prior to the effective date of the *MO&O* are non-attributable.
