

## MUTUAL CONSENT AGREEMENT

This Mutual Consent Agreement (the "Agreement") is made as of August 3, 2007 by and among Family Life Broadcasting, Inc. ("FLB"), American Educational Broadcasting, Inc. ("AEB"), and Educational Media Foundation ("EMF").

WHEREAS, FLB, EMF and AEB desire to jointly consent to mutual contingent minor changes to the facilities of their stations, KFLT-FM, Tucson, Arizona, licensed to FLB, KZAI(FM), Coolidge, Arizona, and KAIC(FM), Tucson, Arizona, both licensed to EMF and AEB is the permittee of KLKA(FM), Globe, Arizona.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged by the parties, and upon the mutual promises and covenants made herein, the parties hereto agree as follows:

1. EMF hereby agrees to request a (i) minor modification of its KZAI(FM) licensed facilities to reduce the effective radiated power ("ERP") to .001kW(H)/8kW(V) and (ii) a minor modification of its KAIC(FM) licensed facilities to change the channel and community of license from Tucson, Arizona to Mammoth, Arizona contingent upon AEB's agreement to modify KLKA's facilities to change the channel, move to a new tower site and change the community of license from Globe, Arizona to Casa Grande, Arizona.
2. AEB hereby agrees to request a minor modification of its KLKA(FM) facilities to change the channel, move to a new tower site and change the community of license from Globe, Arizona to Casa Grande, Arizona contingent upon EMF's agreement to modify its KZAI(FM) licensed facilities to reduce the ERP to .001kW(H)/8kW(V) and modify its KAIC(FM) licensed facilities to change the channel and community of license from Tucson, Arizona to Mammoth, Arizona.
3. FLB hereby agrees to request a minor modification of its KFLT-FM licensed facilities to move to a new tower site and reduce the ERP, contingent upon EMF's agreement to modify its KZAI(FM) licensed facilities to reduce the ERP to .001kW(H)/8kW(V) and modify its KAIC(FM) licensed facilities to change the channel and community of license from Tucson, Arizona to Mammoth, Arizona, as well as AEB's agreement to modify KLKA's facilities to change the channel, move to a new tower site and change the community of license from Globe, Arizona to Casa Grande, Arizona.
4. The parties hereby agree to coordinate and concurrently file with the FCC applications to modify the facilities of their respective stations as described in this Agreement. FLB agrees to compensate AEB as set forth in Exhibit A hereto. The parties agree that, other than the exchange of promises set forth in this Agreement and the compensation set forth in Exhibit A hereto, no other consideration shall be paid or exchanged between the parties.
5. EMF and AEB agree that no change in facilities shall be effectuated by either party unless and until the FCC has granted both parties' applications for their respective above mentioned changes. FLB agrees that should the KFLT-FM application be dismissed, withdrawn or grant is otherwise delayed, EMF and AEB may continue to pursue their respective applications and effectuate the changes in their respective facilities.

6. This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any party whose signature appears thereon and all of which shall together constitute one and the same instrument.
