Dear Mr. Silberberg:

This is in reference to the request filed on November 6, 2017. BBC requests a second extension of the STA granted on October 13, 2016, to continue ND operation pending the filing of the required FCC Form 302 application to update all operating parameters.<sup>1</sup> In support of the request, BBC states that additional time is needed to complete repairs.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for an extension of the STA IS HEREBY GRANTED, and BBC may continue to operate ND using tower #3 of the array, with a maximum of 0.3 kW day and 0.080 kW night. It will be necessary to further reduce power or cease operation if complaints of interference are received. BBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. BBC must file the 302 application if any changes to the operating parameters

are needed due to the required extensive repairs. Otherwise an e-mail must be submitted to my attention to certify the date the station resumed operations (per BL-20040709ADS) with negligible changes.

This authority expires on **May 27, 2018**.
