TECHNICAL STATEMENT

1. This technical statement was prepared on behalf of Cumulus Licensing LLC ("Cumulus"), licensee of KOMS, Channel 297C, Poteau, Oklahoma and KOAI, 1060 kHz, Van Buren, Oklahoma. Cumulus is submitting applications to correct the coordinates of KOMS and KOAI, as such, a radio market analysis is necessary. Cumulus is also the licensee of KBBQ-FM, Channel 274C2, Van Buren, Arkansas and KLSZ-FM, Channel 264C2, Fort Smith, Arkansas. Each of these stations is licensed to a community within a metro county in the Fort Smith, Arkansas Arbitron market. Therefore, this review will verify compliance of commonly owned stations in a rated market.

FORT SMITH, ARKANSAS ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are thirty AM and FM (commercial and non-commercial) stations listed in the Fort Smith, Arkansas Arbitron Market (Market #175). Cumulus controls three FM stations and one AM station in the market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations, with no more than four in the same service, is permissible. Therefore, Cumulus is in compliance in the rated Fort Smith, Arkansas market.

3. Based on compliance in the rated market, Cumulus is in compliance with §73.3555 of the rules, with regard to the applications to correct the coordinates of KOMS and KOAI.

4. The foregoing technical statement was prepared on behalf of Cumulus Licensing LLC by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.3 BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.


