

# §74.1233(D)(2) Non-Adjacent Channel Displacement Waiver Request & Minor Change Channel Preclusion Showing

Pursuant to the recent commencement of full-service station KNBQ(FM) - Central Park, WA, License BLH-20150303AAS, Translator K253BW.L C ceased operation due to received interference as noted in silent authority filing BLSTA-20151109FNM. As a result, the applicant respectfully requests a waiver of §74.1233(d)(2) for this non-adjacent channel "displacement" application. Within this §74.1233(d)(2) waiver request, the applicant has demonstrated the unavailability of a minor change first, second or third adjacent channel as well as the unavailability of a 53rd or 54th minor change I.F. channel based on a similar licensed facility from the present licensed site. As a consequence of the unavailability of a minimum minor change channel and the subsequent commencement of KNBQ(FM), it is believed a waiver of §74.1233(d)(2) for this non-adjacent channel "displacement" is merited in this instance.
