**MAIN STUDIO WAIVER
SECTION 73.1125(a)**

We Have This Hope Christian Radio, Inc. (hereafter “Hope”), is a non-profit religious corporation which operates non-commercial educational Station KOPJ(FM), Sebeka, Minnesota¹; WYNJ(FM), Blackduck, Minnesota, WHPJ(FM), Hibbing, Minnesota and translator K228EW Bemidji, Minnesota. As a non-profit educational entity, Hope relies primarily upon charitable contributions for its expansion and broadcast operations. Thus it must operate within very tight budgetary constraints. Accordingly, Hope does not have the resources to justify funding a separate staff and studio facility for programming its new NCE FM station in WHPJ(FM) Hibbing, Minnesota and also WYNJ(FM) Blackduck, Minnesota. Moreover, Hope does not believe that it is economically feasible for a community to support an independent non-commercial religiously formatted station at the present time which would be capable of providing the financial support for the quality of service that will be available from the studios of Station KOPJ(FM).

For these reasons, Hope respectfully requests that the proposed consolidation of the main studio for the new station in Hibbing, Minnesota and WYNJ(FM), Blackduck, Minnesota with that of Station KOPJ(FM), Sebeka, Minnesota, will serve the public interest. Hope submits that the Section 73.1125 of the Commission’s rules, this instance is consistent with Commission’s dispositions of similar requests by other similarly situated non-commercial educational religiously formatted stations.

Hope will maintain a toll free telephone number so that residents of the Hibbing and Blackduck service areas will be able to contact the studio without charge. In addition, Hope will actively solicit community involvement from within both communities and the communities within the service area. To this end, Hope will associate with ministers and churches in the Hibbing and Blackduck area and within the service to establish an advisory committee which will formulate and exchange ideas on programming and station development. With the use of broadband access to the KOPJ studios, the proposed transmitter site, it is anticipated that separate programming designed for the particular interests of both Hibbing and Blackduck can be achieved.

In sum, the grant of this requested waiver will facilitate the provision of a high quality and diverse religious programming to the Hibbing and Blackduck community, and a level of public service that would otherwise be unattainable due to the financial constraints involved herein. Because such a result would clearly serve the public interest, it is respectfully requested that this waiver be granted.

We Have This Hope Christian Radio , Inc., hereby requests a waiver of Section 73.1125(a) of the Commission’s rules to permit the main location for its WHPJ(FM), Hibbing, Minnesota and WYNJ(FM), Blackduck, Minnesota to be located at the studios of Station KOPJ(FM), 200 Main Avenue South, Park Rapids, Minnesota. Hope proposes to operate the WHPJ(FM) and WYNJ(FM) as satellite stations of KOPJ(FM).
