

## MEMORANDUM OF AGREEMENTS

Alatron Corporation, Inc. (“Alatron”), licensee of Stations WAOQ(FM), Brantley, Alabama, is filing an application to change the community of license of WAOQ from Brantley to Goshen, Alabama. In order to make this change Alatron has entered into agreements with Auburn Network, Inc. (“Auburn”), licensee of Station WGZZ(FM), Waverly, Alabama, and Brantley Broadcast Associates, LLC (“Brantley”), licensee of Station WEZZ(FM), Monroeville, Alabama, for changes to their respective stations. Collectively, the parties are filing the following three contingent applications pursuant to Section 73.3517(e) of the Commission’s Rules:

- Alatron will file an application to change the community of license of Station WAOQ from Brantley to Goshen, Alabama; the station will remain on Channel 262A (the “WAOQ Application”).
- In order to permit the changes requested in the WAOQ Application, Auburn will file an application to change the channel of Station WGZZ from Channel 262A to Channel 232A at Waverly, Alabama (the “WGZZ Application”).<sup>1</sup>
- In order to ensure that the community of Brantley retains local service, Brantley will file an application to change the community of license and frequency of Station WEZZ from 930 kHz at Monroeville, Alabama to 920 kHz at Brantley, Alabama (the “WEZZ Application”).

The WAOQ Application is contingent on grant of the WGZZ Application and the WEZZ Application. The applications are not otherwise contingent. Alatron hereby certifies that it has agreements with Auburn and Brantley to file, prosecute, and implement the WGZZ Application and the WEZZ Application, respectively. The parties will provide redacted copies of the agreements upon request by FCC staff.

<sup>1</sup> In order to accomplish the change of channel at Waverly, Alabama, for WGZZ, a vacant allotment substitution is necessary at Waverly, Alabama. Pursuant to the Commission’s new allotment procedures, “changes to vacant allotments will continue to be made via notice-and-comment rule making procedures.” *See Revision of Procedures Governing Amendments to FM Table of Allotments and Changes of Community of License in the Radio Broadcast Services*, 21 FCC Rcd 14212, ¶ 15 (2006). Thus, this proposal is considered a hybrid filing. *Id.* at ¶ 17. Accordingly, Auburn will be contemporaneously filing a petition for rule making to change the channel of the vacant allotment at Waverly, Alabama from Channel 232A to Channel 262A.


