In evaluating the application for a new construction permit for Yreka, CA BNPTTL-20000830BJB FID 130169, an outgoing interference study was executed at the tower location with an ERP of 20.9 kW using a different antenna and rotation. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference using the OET-69 Longley Rice methodology, the interference when rounded to the nearest 100th percent was found to be zero percent.
