This exhibit consists of this explanatory text and the attached single channel spacing study. As the single channel spacing study will demonstrate, the proposed facility would be in compliance with the provisions of Section 73.207 of the Commission's Rules.

The spacing study lists three facilities to which the proposed facility would be short spaced. The first two of these are to KISD(FM), which is the proposed facility; therefore, these short spacings are moot. The other short spacing is to the C2 construction permit at Lennox, SD (FCC File No. BNPH-20050103AGI).

The short spacing to the authorized Lennox, SD facility should also be considered moot. That facility requested a one-step upgrade to a class C2 allocation from their originally allotted channel. As a result, the Lennox applicant has demonstrated that a reference site for their allocation exists that would be fully spaced to the KISD facility and provides the required city grade coverage. Their authorization, which is the one indicated on the attached single channel spacing study, is pursuant to Section 73.215 of the Commission's Rules, and is required to maintain contour protection to KISD.

Since none of the indicated short spacings are relevant, it is respectfully submitted that the proposed facility would be in compliance with the provisions of Section 73.207 of the Commission's Rules.
