

EXHIBIT 12 (addendum)

Broadcast Interests

Western Broadcasting, LS, LLC hereby supplements the information provided in Exhibit 12 to report the following additional information:

On May 24, 2001, an informal objection was filed against the instant application by Kent A. Kroneman. On June 13, 2001, pursuant to an extension of time granted by the Commission, Western Broadcasting, LS, LLC, filed its Opposition to the Informal Objection.

The assignment applications for KTSP(AM) (Facility ID No. 12325), and KEOT(FM) (Facility ID No. 18140), St. George, Utah (*see* FCC File Nos. BAL-19980507ED and BALH-19980507EE) to which SMGI, through a subsidiary, was previously a party, were amended on March 15, 2001, to report SMGI's assignment of rights to a third party in which Simmons Media Group, Inc. ("SMGI") will hold a non-voting and non-attributable stock interest. A petition to deny the application, as amended, was filed on April 23, 2001. Canyon Media Corporation, the third party and new assignee, filed its Opposition to the Petition to Deny on May 15, 2001, and the Petitioner filed its Reply on May 24, 2001.

On May 18, 2001, SMGI consummated twelve *pro forma* assignment and transfer applications, which were filed on March 26, 2001, and granted on April 4, 2001, to reorganize SMGI. One of the applications sought to assign the licenses of KDXU(AM) and KSNN(FM), St. George, Utah, from Simmons St. George, Inc. to Western Broadcasting, LS, LLC. (*See* FCC File Nos. BAL-20010326ABS and BALH-20010326ABT.) Another sought to assign the license of K269AF, Hurricane, Utah from SMGI to Western Broadcasting, LS, LLC. (*See* FCC File No. BALFT-20010326ABU.) The other applications involved stations owned by SMGI in the Albuquerque, New Mexico, Georgetown, Texas and Salt Lake City, Utah markets and did not involve Western Broadcasting, LLC or Western Broadcasting, LS, LLC. (*See* FCC File Nos. BAL-20010326ABG, BAL-20010326ABL, BALH-20010326ABR, BAPH-20010326ABH, BALH-20010326ABM, BAL-20010326ABO, BALH-20010326ABP, BALH-20010326ABQ, BAPH-20010326ABI, BALH-20010326ABA, BALH-20010326ABC, BALFT-20010326ABD, BALFT-20010326ABE, BTCH-20010326ABV, BALH-20010326ABF, and BALH-20010326ABB.)

On May 18, 2001, Western Broadcasting, LS, LLC consummated the acquisition of the licenses for radio stations KFTZ(FM) (Facility ID No. 18116) and KPLV(FM), Idaho Falls, Idaho (Facility ID No. 33447) (FCC File numbers BALH-20010214ACQ and BALH-20010214ACR, respectively, granted May 11, 2001). On the same date, SMGI consummated the acquisition of Western Communications, Inc., the licensee of KLCE(FM), Blackfoot, Idaho (Facility ID No. 71772, File Number BTCH-20010214ACS), and its FM Translator K249CM, Pocatello, Idaho (Facility ID No. 71781, File Number BTCFT-20010214ACY); KCVI(FM), Blackfoot, Idaho (Facility ID No. 71785, File Number BTCH-20010214ACT) and its FM Translator K266AF, Pocatello, Idaho (Facility ID No. 71784, File Number BTCFT-

20010214ACX); KECN(AM) (Facility ID No. 71780, File Number BTC-20010214ACU);
KBLI(AM), Blackfoot, Idaho (Facility ID No. 87152, File Number BTC-20010214ACV); and
KICN(AM), Idaho Falls, Idaho (Facility ID No. 71775, File Number BTC-20010214ACW).
These applications were granted May 11, 2001.
