**REQUEST FOR CONDITIONAL PROGRAM TEST AUTHORITY**  
**FOR STATION WKXY(FM) – CH. 221A – MERIGOLD, MS**

WKXY(FM) was granted a Construction Permit (File No. BMPH-20071024AAC) to change its city-of-license from Clarksdale, Mississippi to Merigold, Mississippi, and construct new facilities at the site formerly utilized by WZYQ(FM). WKXY's Construction Permit contains the following condition:

*"Program Tests for WKXY (Facility ID #77755) will not commence on Channel 221A with the facilities specified herein until Program Tests for WJNS-FM (Facility ID #72816) commence on Channel 221A with the facilities authorized in BPED-20070611AKN and a license will not be granted for WKXY on Channel 221A with the facilities specified herein until a license is granted for WJNS-FM on Channel 221A with the facilities authorized in BPED-20070611AKN."*

To our knowledge, WJNS-FM has not completed construction of their new facilities. However, on September 12, 2008, the WJNS-FM tower in Yazoo City, Mississippi collapsed and the station is no longer operational. Because WJNS-FM holds a valid Construction Permit to move to Bentonla, Mississippi, it is extremely unlikely that WJNS-FM's Yazoo City facility will be reconstructed. Since the station is not on-air, the potential for interference between WJNS-FM and WKXY(FM) is now non-existent. As such, we hereby request *CONDITIONAL PROGRAM TEST AUTHORITY* to allow WKXY(FM) to commence operation at Merigold, Mississippi, which represents first local service to the community of Merigold.

Even if WJNS-FM were to resume operation in Yazoo City pursuant to Special Temporary Authority, it is unlikely they would be able to do so at their licensed power and antenna height. As such, the protected and interfering contours of the two stations would not likely intersect.

WKXY(FM) is prepared to begin operation utilizing its authorized facilities, provided Conditional Program Test Authority is issued. If WJNS-FM resumes operation at Yazoo City with reduced facilities, we are prepared to submit a Section 73.215 exhibit to demonstrate that no harmful interference exists. Alternatively, we are prepared to reduce WKXY(FM)'s power to alleviate any harmful interference. In the unlikely event that WJNS-FM resumes operation in Yazoo City with its full licensed power and antenna height, we are prepared to terminate WKXY's operation on Ch. 221A, if necessary.
