EXHIBIT A

City of License Change Review

This application seeks to change the community of license of the licensed WLRR, Channel 264A, from Milledgeville, Georgia to Buckhead, Georgia using the city of license change procedures, as outlined in MB Docket 05-210, released November 29, 2006. WLRR will become Buckhead's first commercial service. Starstation herein reviews the proposed change and demonstrates compliance with the Commission's rules/procedures for a change.

As indicated on Exhibit A1, at the proposed site for WLRR at Buckhead, Georgia, Channel 264A meets the Commission's minimum distance separation requirements to all other licensed, applied for, or proposed facilities pursuant to §73.207, with the exception of the current WLRR facility and secondary service LPFM facility WPPP-LP. It is noted that Channel 229 (93.7 MHz) is a fully spaced alternative frequency for WPPP-LP, as noted in Exhibit A2.

Exhibit A3 is the a map demonstrating that the proposed 70 dBu contour fully serves the city of Buckhead. This is an existing tower site, and it is acceptable for use by WLRR as a viable location for a radio tower.

Exhibit A4 shows the areas of signal loss and signal gain as a result of the move.

Milledgeville has a population 19,401 persons, and Buckhead has a population of 171 persons.

There is an area of overlap between the 60 dBu contour of the licensed WLRR at Milledgeville and the proposed site for Channel 264A at Buckhead. The licensed WLRR at Milledgeville provides 60 dBu service to 60,833 persons over 1,925 square kilometers. The proposed WLRR at Buckhead will provide a 60 dBu contour to 45,029 persons over 2,581 square kilometers. The resultant move will create a loss of service to 57,500 persons and a gain of service to 41,715 persons, with a common area of service to 3,336 persons, within the 60 dBu service contours.

Exhibit A4 depicts the gain, loss, and common service areas.

Exhibit A5 shows the protected service contours of existing audio facilities providing service to the loss area. It is noted that WLRR at Milledgeville provides a fourth service to 24 persons over 14.19 square kilometers and fifth service to 421 persons over 67.52 square

kilometers, as presently licensed. The tabulation of loss area services is included as Exhibit A6. Exhibit A7 shows the protected service contours of existing audio facilities providing service to the gain area. It is noted that WLRR at Buckhead will provide a fifth service to 40 persons over 21.80 square kilometers as proposed. The tabulation of gain area services is included as Exhibit A8. As there are no white or gray areas with less than three services in either the loss or gain areas, they are considered well served.

Exhibit A9 is a map depicting the existing stations providing primary service to the community of Milledgeville, Georgia. Attached as Exhibit A10 is a tabulation of those stations. Exhibit A11 is a map depicting the existing stations providing primary service to the community of Buckhead, Georgia. Attached as Exhibit A12 is a tabulation of those stations.¹

Buckhead, Georgia is not located within or immediately adjacent to an Urbanized Area, as designated by the United States Census. Based on the foregoing, the proposed change of community of license for WLRR complies with the Commission's technical rules and guidelines.

1) The signal threshold for primary service to the community of Buckhead is 60 dBu for FM stations and 2.0 mV/m for AM stations.


