



The State of Wisconsin - Educational Communications Board ("State of Wisconsin- ECB") is entitled to be credited with two (2) points as a State-wide network within the meaning of the term in Rule 73.7003(b)(3)(ii), 47 C.F.R. §73.7003(b)(3)(ii). With respect to this credit, the State of Wisconsin - ECB certifies as follows:

1. It has not applied for credit on the basis of diversity of ownership.
2. Through the University of Wisconsin System, the State of Wisconsin has jurisdiction over a large number of college and university campuses state-wide, including the required number of at least five full-time college or university campuses. All such colleges and universities are public institutions of higher learning accredited by a recognized regional or national educational accrediting organization. The State of Wisconsin has formed a state-wide network of NCE radio stations for which it holds the license either through the University of Wisconsin or through the State's Educational Communications Board ("ECB"). These radio stations include within their combined service contours at least five (5) such college or university campuses to which the state-wide network regularly provides programming in furtherance of curriculum. The station which the State of Wisconsin - ECB has proposed for the community of Superior, Wisconsin, will increase the number of campuses that applicant will regularly serve because the campus of the University of Wisconsin-Superior is within the proposed service area for the new station in Superior. Many private colleges and universities are also within the service contours of this state-wide network.
3. In support of this statement, the State of Wisconsin has provided a chart listing all stations for which is presently holds licenses, including at least five (5) college or university campuses that are located within the service contours of licensee's existing stations, including the University of Wisconsin-Superior campus within the proposed Superior station service contour (See Exh -3)
4. The University of Wisconsin System is the model of a state-wide educational broadcast service. Wisconsin Public Radio ("WPR"), the nation's oldest public radio broadcasting service, has been providing educational (as well as informational and cultural) public radio programming to the university and college campuses in the State since 1917. This system has expanded state-wide from a single frequency (9XM/WHA Radio) on the University of Wisconsin-Madison campus. In the 1940s, through WPR, the State of Wisconsin launched the nation's first state-wide FM network, further extending the benefits of educational and other programming throughout the state's school systems in campuses in then-underserved rural communities. By the gradual addition of new frequencies in new locations over the years, the UW System today operates a dual state-wide 24-hour programming service, consisting of the WPR Ideas Network and the WPR News and Classical Music Network. WPR produces over fifteen hours of its own core programming daily on each network. The educational curricula of the UW System's colleges and universities is enriched and furthered by the state-wide network radio service, including such programming elements as:

- A. **University of the Air.** WPR's distinctive lifelong learning service, *University of the Air*, features University of Wisconsin course materials presented by leading faculty members. Program hosts have included Professor Emily Auerbach, a member of the UW-Madison faculty and a part-time WPR staff member.
- B. **The Wisconsin Idea.** is a state-wide educational focus of the State government through the UW System of major significance for the educational goals of the State. The Wisconsin Idea encompasses the concept of lifelong learning and other ways of extending the services of the UW System to the citizens of the State through, among other means, lifelong learning and continuing education programs, of which University of the Air is an aspect.
- C. **Broadcast-Related Links to Educational Opportunities and Content.** WPR's web site and Listener Services Center provide direct links to other formal and informal lifelong learning and other continuing education services related to its daily programming.,
- D. **The Annenberg/CPB Audio-Print Courses.** UW System faculty and WPR developed and produced nearly all of the Annenberg/Corporation for Public Broadcasting ("A/CPB") Audio/Print Courses, a series of college-level courses that were produced for use nationally at two- and four-year post-secondary institutions of higher learning. These programs were initially broadcast in Wisconsin over its state-wide network and distributed for national broadcast as well. WPR remains actively involved as a (non-broadcast) distributor of these programs nationally and worldwide. Among the A/CPB Audio-Print courses offered for university credit through the University of Wisconsin are: *Basic Concepts of Music, Sociological Foundations, Nutrition Today, Introduction to Psychology, Ethics in Business, American History I and II, An Introduction to the History of Women and the Family in America: 1607 - 1870, Principles of Statistics, College Algebra, Introduction to Modern English and American Literature I and II, and Dilemmas in War and Peace.* These A/CPB Audio-Print courses may be taken for university credit through the Independent Learning Office, University of Wisconsin-Extension, located on the Madison campus.

- E. **Other Audio-Print Courses.** Professor Auerbach has developed and produced through WPR a series of audio/print courses on pioneering women writers entitled *The Courage to Write*. These audio series have been and continue to be broadcast by WPR as part of the *University of the Air* service and are taught by Prof. Auerbach in the University's continuing studies curriculum.
- F. **Faculty and Staff On Air.** WPR programming regularly utilizes the services of faculty and staff in such areas as current events, politics and government, and cultural programs. Academic faculty is regularly involved in WPR's 15 daily hours of original programming, including routine participation in the Idea Network's commentary and discussion programs. Such cross-fertilization between the UW System faculty and WPR is another way in which WPR programming connects with and furthers the curriculum on the UW System. Attached to this application is a partial list of such faculty participation in programming. Some examples include Prof. Patricia McConnell (animal health and behavior); Prof. Larry Meiller, whose daily talk program (*Conversations with Larry Meiller*) regularly includes UW faculty and academic staff as expert guests on such topics as conservation, agriculture, environmental science, and other topics related to areas of the UW System lifelong learning curriculum; Prof. Dave Berkman (UW-Milwaukee, Department of Journalism), who hosts a Friday afternoon discussion program (*Media Talk*) which focuses on the political, social, and cultural impact of the mass media; and *To the Best of Our Knowledge*, a weekly two-hour program featuring interviews with leading academics and intellectuals (regularly featuring UW faculty) on a variety of topics, including politics, history, cultural affairs, and the arts.
- G. **UW Faculty Involvement as WPR Staff.** Other UW System academic/faculty involvement with WPR includes faculty members who teach broadcasting and broadcast journalism, such as WPR staff member, Professor Larry Meiller (UW-Madison courses in agricultural journalism); former WPR Director, Jack Mitchell, now a faculty member in the UW-Madison Journalism Department, who serves as Academic Chair of WPR's parent entity, the Educational Communications Division of the University of Wisconsin-Extension, and teaches a course in the history of public broadcasting.
- H. **WPR Staff Serving as UW Faculty and Guest Lecturers.** Several WPR staff members also teach courses or serve as guest lecturers on UW System campuses, including the UW-Madison Communications Arts Department, Journalism Department, Law School, and School of Business; the UW-Superior School of Communicating Arts; and the UW-La Crosse Department of Communication Arts/Journalism.

- I. **Cultural Programming and Liberal Arts Curriculum.** WPR produces and/or broadcasts a great deal of music, arts, literature, and drama programming. Such programs, through the state-wide network and the cross-fertilization between its academic and broadcasting functions, feed into furtherance of the liberal arts curriculum of corresponding academic departments at the various UW System campuses. A small sample of such programs include the Metropolitan Opera; the Lyric Opera; *Chapter A Day*, a daily (M - F) program of readings of classical and current works of fiction that has been produced and performed by WPR staff since the 1920s. This fall (2001), a WPR-produced 15-part dramatic series, *A Canticle for Liebowitz*, will be distributed for broadcast through National Public Radio to all of its member stations in Wisconsin (as well as nation-wide).
- J. **Internships.** All WPR regional bureaus – Eau Claire, Green Bay, Milwaukee, La Crosse, Superior, and Madison – routinely offer internship opportunities for journalism or communication arts students. In addition, each summer the UW-Madison bureau provides special minority internship opportunities under the auspices of the UW-Extension AA/EEO Office and the Office of the Mayor of Madison. In addition, WPR professional staff routinely provide informal career counseling for UW journalism and communications arts students.

The State of Wisconsin certifies that it will continue to provide programming through its state-wide network at least the level set forth in this exhibit through at least the four-year period after a license for the proposed station has been granted.

This statement and supporting exhibits have been placed in the local public inspection file, which is located at the main studio site in Vilas Hall, 821 University Avenue, Madison, Wisconsin, and at the Wisconsin Public Broadcasting Center, 3319 West Beltline Highway, Madison, Wisconsin.
