

# **Compliance with Rural Radio Policies**

## **Urbanized Area Preclusion Study**

### **Proposed Minor Modification Application**

#### **KQTC - Channel 258C2 - Christoval, Texas**

**February 2, 2015**

Saver Media, Inc. ("Saver"), permittee of KQTC construction permit BMPH-20130725ADU, Channel 258C2, Eldorado, Texas proposes to modify KQTC to change the community of license to Christoval, Texas.

The proposed modification would further the Commission's allotment priorities and result in a preferential arrangement of assignments under Section 307(b) of the Communications Act of 1934, as amended, by advancing Priority 3 of the Commission's assignment priorities<sup>1</sup>. The proposal would introduce an first local transmission service to Christoval, Texas, without creating any white or gray area, and without depriving any community of local service.

At present, the 307(b) balancing required is simply whether the modification would serve the public interest and outweigh making no modification at all. The proposed community of license, Christoval, Texas is located approximately 20 km. south of the San Angelo, Texas Urbanized Area. However, the proposed KQTC facility nor any subsequent modifications of KQTC will result in service providing an FCC F(50,50) 70 dBu contour serving any part of the San Angelo, Texas Urbanized Area. Christoval, Texas is not located in the San Angelo, Texas Urbanized Area and thus the proposal cannot be considered to be an additional service to the Urbanized Area.

First, as demonstrated in Exhibit One, the KQTC hypothetical 70 dBu city grade contour from the proposed KQTC allotment site does not reach any part of the San Angelo, TX Urbanized Area.

Second, also as demonstrated in Exhibit One, the KQTC facility FCC F(50,50) 70 dBu contour, which is currently operating under program test authority does not reach any part of the San Angelo, TX Urbanized Area.

Third, Christoval, Texas is a Census Designated Place with a 2010 US Census population of 504 persons. It is well established that "community" status is generally satisfied if a place is listed in the U.S. Census as a "Census Designated Place,"<sup>2</sup> Christoval, Texas is located in Tom Green County, Texas and is not located within the boundaries of the San Angelo, Texas Urbanized Area (See Exhibit One). Therefore it is believed that the Commission's decision in Faye and Richard Tuck, Inc., does not apply in this instance and there is no requirement that a "Tuck" Study for Christoval be provided to determine independence from the Urbanized Area.

Finally, a detailed engineering study was conducted to determine the possibility of moving the proposed facility closer to the San Angelo, Texas Urbanized Area. The study determined that there are no existing tower sites to which the facility could move pursuant to a minor modification that would allow the proposed station to cover fifty percent or more of the San Angelo, TX Urbanized Area.

KQTC operates on Channel 258 and must protect third adjacent FM station KCLL, Channel 261C2, San Angelo, TX. The 73.215 contour protection minimum distance to KCLL ranges from 51.5 km. for a Class C2 facility to 48.5 km for a Class A facility. The proposed KQTC facilities FCC F(50,10) 100 dBu interfering contour cannot overlap the KCLL FCC F(50,50) 60 dBu protected contour using Section 73.215 contour protection. All existing registered tower sites were studied assuming the maximum class facility for the Class being analyzed. All studies assumed a one bay antenna with a radiation center the same as the overall height of the tower. Only towers within fifty kilometers to the nearest part of the San Angelo, Texas Urbanized Area and/or within forty kilometers of Christoval are shown. Only towers located within the legal FCC spacing for Section 73.207 and 73.215 for the appropriate Classes are shown. Class A, Class C3 and Class C2 facilities were considered.

Exhibit Two is a map showing all existing ASR sites that were evaluated to determine if fifty percent coverage of the San Angelo, TX Urbanized Area was possible for KQTC at Christoval, TX. A total of eight registered tower sites were identified including the current KQTC licensed site.

Exhibit Three is a spreadsheet listing the eight ASR sites that were evaluated with key information about each site. This includes the distance from that tower to the closest point of the Urbanized Area. Four ASR's were determined to meet the FCC spacing requirements and were included in Exhibit Two. Four other ASR's were identified and included due to their proximity to the area. However, none of these ASR's meet FCC spacing requirements and they were not included in Exhibit Two.

The following ASR sites were determined to potentially operate as Class C2 facilities. ASR Site #1289229, which is the tower where KQTC is located proved to be the site coming closest to reaching the San Angelo Urbanized Area. This site and the FCC F(50,50) 70 dBu contour are shown in black on Exhibit Two. The transmit antenna center of radiation was assumed to be located at the top of the tower at 136 meters AGL operating with 50 kW at 136.6 meters HAAT. ASR Site #1041542 and the FCC F(50,50) 70 dBu contour are shown in red on Exhibit One. The transmit antenna center of radiation was assumed to be at the top of the tower at 140 meters AGL. Once again none of the San Angelo Urbanized Area will be reached with an FCC F(50,50) 70 dBu contour. ASR Site #1230883 and the FCC F(50,50) 70 dBu contour are shown in blue on Exhibit Two. The transmit antenna center of radiation was assumed to be at the top of the tower at 103 meters AGL. None of the San Angelo Urbanized Area will be reached with an FCC F(50,50) 70 dBu contour. Finally, ASR #1257290 was only considered as a Class C3 facility. This site and the FCC F(50,50) 70 dBu contour are shown in green on Exhibit Two. The Class C2 facility from this site would be heavily restricted due to contour overlap with KCLL. Printouts of the all eight ASR sites shown at the end of this study. This includes the four sites that meet the minimum FCC spacing requirements and the four that did not.

It is not possible to reach any part of the San Angelo Urbanized Area with an FCC F(50,50) 70 dBu contour from any of the existing ASR sites. Therefore it is believed that this KQTC minor modification application is in compliance with Commission policies established in Rural Radio<sup>3</sup>.

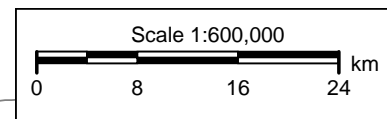

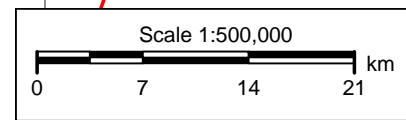
