

Exhibit 5 – Local Radio Ownership Rule Compliance Showing

Citadel Broadcasting Corporation (“Citadel”) is the ultimate parent of Radio License Holding CBC, LLC, the licensee of Station WMAS-FM, Springfield, Massachusetts (Facility ID No. 36543). This application seeks to make a minor change to the licensed facilities of WMAS-FM to, among other things, change the station’s community of license from Springfield, Massachusetts to Enfield, Connecticut.

For purposes of the local radio ownership rule, WMAS-FM currently is part of the Springfield, Massachusetts Arbitron Metro. Springfield is located in Hampden County, Massachusetts, which is located within the Springfield, Massachusetts Metro, as defined by Arbitron. The attached FCC Geographic Market Definition for Springfield, Massachusetts (the “Springfield Report”) was compiled on December 16, 2010 using BIA Research, Inc.’s *Media Access Pro* database. The Report lists all radio stations that are licensed to communities within the counties comprising the Springfield, Massachusetts Metro or that Arbitron designates as “home” to that Metro. In addition to WMAS-FM, Citadel controls Station WHLL(AM), Springfield, Massachusetts (Facility ID No. 36545), a combination of one FM and one AM station. As demonstrated in the Report, there are 30 operating stations in the Springfield, Massachusetts Metro, as so defined. Under the local radio ownership rule, a person or single entity (or entities under common control) in a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations may have a cognizable interest in not more than 7 commercial radio stations in total and not more than 4 commercial stations in the same service. In the event that WMAS-FM remains “home” to the Springfield, Massachusetts Metro after the change of the station’s community of license as proposed, Citadel’s continued control of one FM and one AM station in this Metro will fully comply with the local radio ownership rule.

Upon the grant of this Application, the community of license of WMAS-FM will be changed to Enfield, Connecticut. Enfield is located in Hartford County, Connecticut, which is located within the Hartford-New Britain-Middletown, Connecticut Metro, as defined by Arbitron. The attached FCC Geographic Market Definition for Hartford-New Britain-Middletown, Connecticut (the “Hartford Report”) was compiled on December 16, 2010 using BIA Research, Inc.’s *Media Access Pro* database. The Report lists all radio stations that are licensed to communities within the counties comprising the Hartford-New Britain-Middletown, Connecticut Metro or that Arbitron designates as “home” to that Metro. As demonstrated in the Hartford Report, there are 33 operating stations in the Hartford-New Britain-Middletown, Connecticut Metro, as so defined. Citadel’s control of one FM station in this Metro, WMAS-FM, will fully comply with the local radio ownership rule.
