

EXHIBIT 1 – Additional applicant information

St. Lawrence University, through its non-commercial educational service “North Country Public Radio,” has provided NCE service to the isolated and sparsely populated area of northern New York State, since it obtained its first authorization for station WSLU over 40 years ago. Terrain issues as well as proximity to Canadian allocations have made it necessary to install a network of seven low to medium powered full-service stations and twenty-four FM translators to provide service to this unique and underserved population and market.

Despite considerable effort over the years, reception issues continue to be a concern in some locations because of difficult terrain. The proposed new full-service station would provide much improved coverage in the Cape Vincent area, permitting users with lower quality in-home receivers to use our service.

Although not considered a "local applicant" per 47 C.R.F. 73.7000, North Country Public Radio's dedication to "localism" and service to local communities in the region is widely known. North Country Public Radio is considered the source of record for local content in northern New York State, and has won hundreds of awards for local and regional service and content, including the national Edward Murrow Award for excellence in broadcast journalism.

SECTION IV, Point System Factors

Applicant does not maintain a local presence (as defined in 47 C.F.R. 73.7000) within 25 miles of the reference coordinates for Cape Vincent, NY and does not claim the localism credit for this application. Thus the applicant has answered “NO” to Section IV, question 1.

The 70 dbu contour of the proposed station does not overlap the 70 dbu contour of any other authorized radio station in which any party to the this application has an attributable interest. Thus the applicant qualifies for providing “Diversity of Ownership” with this new service and has answered “YES” to Section IV, question 2.

As 47 C.F.R. Section 73.7003 requires that the applicant’s governing documents require that this qualification be maintained, the following Article was adopted by the applicant’s Board of Trustees on October 12,2007 to revise the “By-Laws of St. Lawrence University.”

ARTICLE XIV

Preamble: The following amendment to the Bylaws of St. Lawrence University was adopted in compliance with Federal Communications Commission's requirement that St. Lawrence University, through its public radio station WSLU/North Country Public

Radio, will not, at least until four years after the construction of the facilities applied for operate any other radio broadcast facility that has an overlapping coverage area with the transmitter for which WSLU/North Country Public Radio is submitting an application coincidental to this amendment adoption.

Therefore, be it resolved that the Bylaws of the University be and hereby are amended to add Article XIV to read as follows: Diversity of Ownership with respect to noncommercial broadcast stations owned by St. Lawrence University: The University shall maintain local diversity and localism of ownership with respect to the stations that will result from the University's applications for new noncommercial FM stations filed during the October 2007 FCC application period, as those terms "diversity" and "localism" are defined by the Federal Communications Commission in sections 73.7000 and 73.7003 of its rules (47 C.F.R. 73.7000 and 73.7003). This provision is intended to comply with the rules of the comparative selection procedures of the Federal Communications Commission as codified in Sections 73.7000 and 73.7003 of that agency's rules.
