MULTIPLE OWNERSHIP

Foxfur Communications, LLC (“Foxfur”) is the licensee of WOLF-FM, DeRuyter, NY. It is commonly-owned with WOLF Radio, Inc., licensee of WOLF(AM), Syracuse, NY, WWLF-FM, Oswego, NY, and WMVN(FM), Sylvan Beach, NY. It is also commonly-owned with Cram Communications, LLC., licensee of WSIV(AM) E. Syracuse, NY, and WOSW(AM), Fulton, NY. Lastly, it is also commonly-owned with Renard Communications Corp., licensee of WNDR-FM, Mexico, NY. All of the aforementioned commonly-owned stations except WMVN(FM) are located within the Syracuse, New York market as designated by Nielsen Audio (formerly Arbitron). The market consists of three counties: Onondaga, Oswego and Madison. Although in Oneida County, WMVN(FM) is presently recognized by the Commission as being home to the Syracuse, NY market. Based on the Commission's multiple ownership rules, in a market with between 30 and 44 stations, a party may own and/or have a TBA with up to 7 commercial radio stations, not more than 4 of which are in the same service. Thus, Foxfur with common ownership in four FM stations and three AM stations is in compliance with the Commission's multiple ownership rules.
