

AMENDMENT TO ASSET PURCHASE AGREEMENT

VERMONT PUBLIC RADIO, a Vermont non-profit corporation, **PAMAL BROADCASTING, LTD.**, a New York corporation ("Pamal"), and **6 JOHNSON ROAD LICENSES, INC.**, a New York corporation, hereby amend that certain Asset Purchase Agreement among them dated April 13, 2016 with respect to the proposed assignment of the FCC construction permit for FM translator W242CE, Rupert, Vermont, to restate the first sentence of Section 5.2 to read as follows:

Section 5.2 Filing of Minor Change Application. Promptly following the filing of the Application, Seller agrees to file with the FCC an application to modify the Permit to relocate the transmitter to a site in the Glens Falls, New York area to be specified by Buyer for use as a translator for Buyer's Station WMML(AM), Glens Falls, New York (the "Minor Modification Application").
