The Rock FM Community Presence




Figure 1: The Rock FM Locations

Figure 1, below, is a map of the St. Cloud community area that plots the residences of each of Applicant's board members. Figure 1 demonstrates that the Rock FM Headquarters and each board member residence is within 5 miles of St. Cloud, MN. St. Cloud is the 282nd Urban Market in population¹ Therefore, the established community presence requirement is met by both criteria. All board members have resided in the community for 2 years and the applicant headquarters has been located in the community for two years.
