FTS also owns 100 percent of the outstanding shares of (1) Fox Television Stations of Philadelphia, Inc., licensee of WTXF-TV, Philadelphia, Pennsylvania; and (2) Fox Television Stations of Birmingham, Inc., which, in turn, owns 100 percent of the outstanding shares of both WBRC License Inc., licensee of WBRC(TV), Birmingham, Alabama, and WBRC and WGHP Holdings Corporation, which owns 100 percent of the outstanding shares of FTS North Carolina, Inc., which, in turn, owns 100 percent of the outstanding shares of WGHP License, Inc., licensee of WGHP(TV), High Point, North Carolina.

FTH owns 100 percent of the outstanding shares of NWCG Holdings Corporation, which owns 92.79 percent of the outstanding shares of New World Communications Group Incorporated (NWCGI), 4/ which owns 100 percent of the outstanding shares of NWC Holdings Corporation, which owns 100 percent of the outstanding shares of NWC Intermediate Holdings Corporation, which, in turn, owns 100 percent of the outstanding shares of NWC Acquisition Corporation, which owns the following station interests:

- (1) 100 percent of the outstanding shares of New World Communications of Kansas City, Inc., which owns 100 percent of the outstanding shares of WDAF License, Inc., licensee of WDAF-TV, Kansas City, Missouri
